It's time to renew your canoe, kayak, or paddleboard storage space for the **2026 season**.

If you wish to continue renting a space and storing your craft, your renewal is **due by March 31, 2026**. Please submit the enclosed **2026 SDRA Canoe/Kayak/Paddleboard Waiver Form** along with your payment of **\$100.00**. Checks should be made payable to **South Down Recreation Association**, mailed to **South Down Recreation Association, 14 Country Club Road, Suite 6, Gilford NH 03249** and must be received no later than **March 31, 2026, No Exceptions**.

All stored crafts are required to display a **craft tag number** that corresponds with the rack number assigned to your space. If you intend to **relinquish your space**, please notify us as soon as possible so we may offer the spot to the next individual on the waitlist.

Please remember that all crafts must be **removed by October 31st** each year and may return to the racks **beginning April 1st**.

Additionally, all rented spaces must be **occupied by June 15, 2026**. Any space not in use after that date will be reassigned to the next person on the waitlist.

Small Watercraft Rack Storage Policy and Registration Form

- Racks spaces for canoes, kayaks, or paddleboards (crafts) will be assigned on a 'first come-first served' basis to owners in SDRA only. Only one Rack Space Per Unit is allowed. All owners must be 100% up to date on fees owed to SDRA in order to rent a space.
- Each rack may hold **no** more than 2 crafts.
- The fee is \$100.00 per season. **Payment is due by March 31, 2026. If Payment is not received by March 31, 2026, rental privileges will be lost. NO EXCEPTIONS**
- **Crafts can be stored from April 1st and must be removed from the racks no later than October 31st, NO EXCEPTIONS.**
- The craft must be placed on the rack in a manner that does not interfere with easy access to crafts in abutting racks or pose a hazard to other rack users. **Crafts must be stored upside down.**
- Owners are required to, and are responsible for, securing their craft(s) to the racks with a lock.
- **ANY** craft found in the storage area that is not secured in a rack will be removed at the craft owners' expense.
- All craft(s) stored are required to display a craft tag number which coincides with the rack number your craft is stored in. If a craft(s) is replaced, the owner will be responsible to purchase new tags through management.
- Interpretation of this policy or decisions regarding a user's adherence to this policy will be made by the SDRA appointed agent – Management.
- The Association assumes no liability or responsibility for damage or loss to any property stored on SDRA property or any person. Use of the rack storage is at the sole risk of the users and craft owners.
- **Rack must be occupied by June 15th with a craft and utilized, if not, you will forfeit your rack, and it will be assigned to the next person on the waitlist.**
