In the Making of 40 Years: The “Golden Invoice” Giveaway

TERMS & CONDITIONS

1. The '40th Anniversary Giveaway' (“Giveaway”) is conducted by Document Management Tasmania Pty Ltd (ACN 629 796 103) of 16 Ruthwell Street, Montrose TAS 7010 (“DMTas”).

2. The Giveaway commences at 12.00am on 1st July 2026 and closes at 11.59pm on 16th December 2026 (the “Giveaway Period”).

3. Information on how to enter and prize details set out in all communications regarding the Giveaway form part of these Terms & Conditions. Any entry not complying with these Terms & Conditions is invalid. Entry into this Giveaway and the acceptance or receipt of a prize by the Winner is deemed as acceptance of these Terms & Conditions.

4. The Giveaway is open to businesses or individuals who:
 - (a) Are not a member of the immediate family of employees of DMTas or businesses owned by a member of the immediate family of employees of DMTas or DMTas' related entities directly involved in the Giveaway (as determined by DMTas).

(b) Are not employees of DMTas or DMTas' related entities directly involve in the Giveaway (as determined by DMTas).

(c) Are a customer of any DMTas services at the time of entry.

(d) Are a business of Tasmania at the time of entry.

5. To enter, during the Giveaway Period individuals must:

6. Only one invoice can be submitted monthly, and each valid invoice meeting the requirements will be taken to be a separate entry.

7. Invoices will be randomly selected by a barrel draw conducted by DMTas on the first Tuesday of each month from the subsequent month when the Giveaway begins at DMTas office, to determine which entrant will be entitled to the Prize (the "Winner").

8. There will be “1” monthly winner. Each prize will be drawn monthly in accordance with paragraph 7 above during the Giveaway Period and will consist of \$4,000.00 worth of free products or services that the business does not currently have with DMTas. (“Monthly Prize”)

9. The total 10 Giveaway prizes worth a total of \$40,000.00 of free DMTas services.

10. The value of each Monthly Prize is based on the recommended retail value provided by the supplier and is correct at the time of printing. Prizes cannot be taken as cash. Prizes can only be claimed for a product or service of DMTas that the Winner has not been utilised. Prize cannot be claimed to pay off existing accounts.

11. DMTas will notify and announce the Winners of the Monthly Prize by telephone or email and will publish the name of the Winners online at DMTas LinkedIn & Newsletter.

12. DMTas will arrange for any delivery and/or implementation of the prizes within Tasmania, after the selection of the winning entries, by mutual agreement with the Winner.

13. If any Winner fails to claim their prize within “**60 days**” of notification and announcement, all entitlements to any prize are forfeited by the Winner. The prize will be returned to the pool and redrawn.

14. If for any reason this Giveaway is not capable of running as planned (including, but not limited to fraud, technical failures or any other causes beyond the control of DMTas which corrupt the conduct of this Giveaway), DMTas may, terminate or modify the Giveaway as required.
