On the Championship 18 at Bayberry Hills, carts **are required** until 2pm on Friday, Saturday, Sunday, and holidays.

Walking is allowed as follows:

Bass River – 7 days per week – all day  
Links Course – 7 days per week – all day  
Bayberry Championship Course – Monday–Thursday all day

## **TEE TIMES**

Yarmouth Golf uses Club Prophet Systems (CPS) for both public and membership bookings. Bookings can be made through the “Book Now” tab at [www.golfyarmouth.com](http://www.golfyarmouth.com) or through the Yarmouth Golf App.

Instructions for setting up an account, including how to book tee times as well as how to create lists of your regular playing partners (“buddy list”) can be found on our website under the “member” tab.

**Members may reserve a tee time 3 days prior starting at 7pm.**

To make a booking through the pro shop, you may call or visit the pro shop AFTER 2 pm on the day prior to the reservation.

Tee time cancellations can be made online or with the app up to 2 hours prior to your reservation.

Yarmouth Golf cannot guarantee play on any specific day or time or with any specific partners. The availability of tee times may be affected by a variety of circumstances including maintenance, weather, tournaments, outings, or prior daily fee reservations. In order for a single player to book a tee time, a two-some or three-some must already be booked in that time slot. Singles are not allowed to book a tee time where no other players are booked.

## **ANNUAL MEMBER NO-SHOW POLICY**

- Members may book/change/edit/cancel their reservation up to 2 hours before their tee time.
- If the tee time is not cancelled online or through the pro shop prior to the 2 hour deadline, the member will be deemed a “no show”.
- We encourage all members to make changes as soon as practical to open the tee sheet to other players. With that in mind, the following policy has been adopted and approved by the Golf Enterprise Committee:
- **Should a member receive three “no-shows”, they will be suspended for one week.**
- **If a member “no shows” 3 times or more after initial suspension, they will be suspended for two weeks.**
- **If member “no shows” 3 further times, they will be suspended for the season.**

**Should a suspension be necessary, the member will be notified by the email on file.**

## **LEAGUE PLAY**

Block times for league play are held at Bass River Golf Course three days per week and run from May 1 – Columbus Day.

The 60's League – Wednesday's (limit 92 players)

Bass River 18 Hole Ladies League – Tuesday's (limit 56 players)

Bass River 9 Hole Ladies League – Tuesday's starting on  
Hole #10 (limit 40 players)

Raiders & Forty Thieves – Sunday's (limit 56 players)

*\*There is no league play on holidays and holiday weekends including the week of July 4.*

*\*\*All block times are subject to availability.*

League members must abide by league rules set by Yarmouth Golf and agreed to by the league presidents as well as the policies and procedures described here.

## **CLUB TOURNAMENTS**

Various club tournaments are run throughout the year, usually on weekends and some holidays. These tournaments are open to members only, with the exception of our Member-Guest Tournament. Registration opening and closing dates can be found on our website under the Tournament Registration tab. Registration is done online at [www.golfyarmouth.com](http://www.golfyarmouth.com) under member/tournament registration.



## **MEMBER CONCERNS**

The following process has been implemented so that members have a place to go with their concerns, complaints, and ideas. For a concern to be considered by Yarmouth Golf, it is imperative that the following steps be followed:

1. The member should try to resolve their concern directly with a staff member.
2. If not resolved, the member must bring their concern by e-mail or in writing to an Operations Manager.
3. If the member is not satisfied with the outcome, the member's communication will be forwarded to the Director of Golf along with the Operation Manager's recommendation.
4. The issue will then be brought to the Golf Enterprise Committee from the Director of Golf if the member is still not satisfied with the recommendation given.
5. If the member is not satisfied with the Golf Enterprise Committee's decision, the GEC will forward the issue, along with an explanation of the remedy presented, to the Select Board for final consideration.

## **REFUND POLICY**

Requests for refunds are authorized by the Golf Enterprise Committee under the following guidelines:

- Refunds will be considered only for documented medical reasons if a member has played less than five (5) rounds that year.
- If a refund is authorized, the refund will be prorated relative to the members play history. Eighteen hole play will result in a \$65 pro rate; nine hole play will result in a \$45 pro rate.
- All passes purchased prior to April 1, 2025 must be requested by April 30, 2025 **OR** 30 days from the date of purchase.
- Member passes are non-transferable and cannot be extended to a subsequent year.
- The GEC will decide on the issuance of a refund and present their decision to the Director of Golf for notification to the member.

The request must include:

- The members golf pass number
- The date and method of payment of the annual fee
- Documentation from a medical professional indicating the medical reason for the pass holder's requested refund

## **GOLF CART USAGE**

- Golf carts must always stay on the cart paths on all Par 3 holes. Carts must also always stay on the cart paths around tees and greens on all holes.
- At no time are non-handicap golf carts allowed to go inside of the golf cart directional signs, ropes, or stakes.
- The areas above are considered restricted areas.
- The 90 degree rule can be put into effect at the discretion of the Golf Course. Under certain conditions, carts may be restricted to the rough only. If golf cart use is restricted, it will be posted in the Pro Shop.
- Any member who purchases a cart at the single cart rate agrees that no other rider will join him/her during the round without paying for the other half of the cart. Violators will be restricted in their ability to purchase a cart at the member rate in the future.
- All carts **MUST** be returned to the designated cart drop-off area.
- Carts are not allowed in the parking lot at Bass River.
- If a cart is observed by a staff member in a restricted area as outlined above, the staff member will notify the Pro Shop or Ranger immediately and will identify the cart number, the exact location of the cart, and give a description of the infraction. The staff will report the infraction to the Manager on Duty.
- Both the operator and the passenger of the cart will be given a verbal warning by the Manager on Duty for the first and second offense, and the warning will be recorded in a file maintained by the Director of Golf. The third offense will result in the Manager on Duty confiscating the golf cart. There will be no refund of the cart fee or greens fee.
- Any offense by a member, either operator or passenger, will be recorded and kept on file by the Operations Manager. The third offense will result in the loss of golf cart rental privileges for a period of two weeks.

## HANDICAP FLAG POLICY

Handicap flags/placards will be made available to those golfers who have a special need, or for various circumstances, are unable to walk between the fairway cart boundaries and the green. These flags are for golfers who present a valid handicap placard issued by any state or by a letter from a physician with supporting documentation. The following rules will apply:

- Handicap flags/placards will be requested at the time of registration. By requesting a flag/placard, the golfer will indicate his/her acceptance of the handicap rules.
- The flag/placard must be affixed to the golf cart and be readily visible during the round.
- When leaving the teeing area and proceeding to the ball on a Par 3, the 90 degree rule will apply when crossing from the cart path to the fairway.
- The flag/placard entitles the golfer to go beyond the fairway cart boundaries to address a ball. All carts are prohibited from those areas designated as “environmentally sensitive”.
- The cart will be permitted **no closer than 15 feet from the fringe area** of the green and will be parked so as not to interfere with the play of other golfers. **No carts are to be driven in areas between the green and the bunker.**
- No golf carts are permitted in the parking lot at Bass River.
- After use by the golfer, the cart must be returned to the designated cart drop-off area.

These rules apply, without exception, to all golfers requesting a handicap flag/placard. The rangers and staff have been instructed to warn any golfer who violates or abuses these rules and to report such warnings to the Operations Manager. Failure to heed such warning will result in loss of privilege to use a handicap flag/placard. Repetitive

violations will result in further disciplinary action which could include suspension of golf privileges.

## **GENERAL INFORMATION**

### **PACE OF PLAY**

The expectation for an 18 hole round is 4 hours, 15 minutes. The link below offers tips and ideas to keep play moving. Please review the recommendations from MassGolf at:

In addition to the role that the golfer plays in keeping pace, Yarmouth Golf has established the following policy which now gives authority to the Ranger or the Manager on Duty to act as follows to speed up play:

Our rangers are equipped with ipads that will show them the time a group has teed off. They also have access to a GPS system that can indicate the group that may be falling behind. This allows them to quickly address the group in question, check on their status, and assist them in moving along. If, for a second time the group has not kept up with the pace of play, they will be asked to pick up their ball and move forward to get back into the desired position. If the group fails to pick up, or again falls behind, the Ranger will then call the Manager on Duty, who will have the option to suspend play and discontinue the groups round at that point.

It is the objective of Yarmouth Golf to make the golfing experience at Bass River and Bayberry Hills enjoyable for all golfers. We hope that these recommendations and this policy will improve pace of play and make golfing at Yarmouth Golf an enjoyable experience.

## **RECIPROCAL PLAYING PRIVILEGES**

The six municipal golf courses on Cape Cod have a reciprocal agreement. Any member of these municipal courses may play any of the other municipal courses for a greens fee of \$30. The participating courses are as follows:

## **PRO SHOP CREDITS**

Credits may be used for pro shop merchandise. Credits may not be used for golf carts, greens fees, annual fees, driving range charges, and gift cards. Credits expire on December 31. Credits are non-transferable and can only be accessed by the account holder.

## **HANDICAPS**

Yarmouth Golf is a member of the USGA GHIN Handicapping System and provides handicap services through the Massachusetts Golf Association (MGA). Members can obtain a handicap by following this link the MassGolf:

<https://www.golfnations.com/mass-golf/?cid=8558>. Players may enter their scores through the apps available through USGA.

## **DRESS CODE**

All players are required to wear proper and clean golf attire. Both men and women are required to wear golf shirts. Tee shirts and jeans are not allowed.

## **PLAYER RESPONSIBILITY**

Be at the golf course at least 20 minutes prior to your tee time. Each player must register at the Pro Shop before play. Doing so will register your name with the starter and will also let them know if you are playing 9 or 18 holes and if you are walking or riding. A paper receipt of your purchase for your records is available upon request.

Each player must have his/her own bag and clubs. Rentals are available at both Pro Shops.

There are no “ride-alongs” at either course. This includes spouses, children, grandparents, boyfriends, girlfriends, etc. **Only players who have paid for a round of golf and have clubs are allowed on the course.**

The maximum number of players per group is four. There are no exceptions.

The golf course restaurant concessionaire has exclusive rights for providing alcohol on the golf course property. No outside alcohol is allowed and is grounds for immediate expulsion.

## **GUIDELINES FOR SUSPENSION**

- Behavior offensive to patrons or employees of the course, including loud and offensive language
- Any abuse of the tee time system outside of normal parameters for obtaining tee times
- Alcohol use is prohibited in the parking lots. This is policy and Town of Yarmouth ordinance. Alcohol may be purchased and consumed on the course from the concessionaire in designated areas only.
- Non-cancellation or no-show for a scheduled tee time
- Failure to abide by directions issued by the Starter, Ranger, or any authorized member of the course management
- Member purchasing a 9 hole cart and continuing past the ninth hole
- Member starting on any part of the golf course without prior Pro Shop approval or playing holes out of sequence without management approval
- Playing or practicing on a course that has been closed
- Play of more than four in a group
- Practicing on the course outside of the designated practice areas
- "Sneaking on" the golf course without checking in at the pro shop
- Violation of the driving range policy, including collecting balls from the driving range, taking balls from the driving range for use at another time, taking baskets, or utilizing the driving range without proper payment
- Not exercising proper care of the course. It is the responsibility of each player to repair ball marks, replace divots, and rake bunkers.
- Play of more than one ball on the course is prohibited.

**Suspension or revocation decisions will be made by the Director of Golf.**
