A. Services of Funeral Director and Staff

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding remains) It includes a proportionate share of the taxes, licenses, utilities and business expenses required to serve the public. Our charges include, but are not limited to, consultation with the family, clergy, cemetery or common carrier, administrative and clerical services, preparation of the death certificate, necessary permits and filing of death certificate with appropriate agencies. Placement of obituary notices, preparing funeral programs, guest registry material including armbands, pens, Koden book and supervision of the services as determined by the family. There will be a charge for each service requested or required.

This fee for our services will be added to the total cost of the funeral arrangements selected.
