The percentage of District representation is based on each county's population within WCSWD: Putnam County @ 36,726 = 69%; and Parke County @ 16,156 = 31% (2020 census = 52,882)

The per capita expenditures totaled <u>\$4.63</u>. Each county contributed \$2.25 per person; based on their population. The remaining budget expenditures were taken out of WCSWD's capital reserve, reducing it by <u>\$90,431</u>.

Putnam County contributions are paid by the county's hazardous waste fund.

Rural Recycling Centers

WCSWD contracted the collection and transportation of 3 rural recycling drop-off centers through W. Enterprises, Crawfordsville, IN. Centers are for **residential use only**. *Businesses*, *schools*, *churches*, *and other organizations are strictly prohibited due to limited space & budget*.

WCSWD also provided grant funding for the townoperated recycling drop-off center located in Bainbridge, Indiana (Putnam County).

404 tons of residential recyclables were collected at the 4 rural drop-off centers in the past 12 months and diverted from landfills. Less contamination in recycling bins may account for up to 5% decrease in overall tons.

Recycling drop-off centers accept the following items:

Co-Mingled: plastic food containers #1-7, glass bottles/jars (clear and colored), aluminum/steel food & beverage cans

Paper Items: newsprint, catalogs, magazines, phone books, soft-bound books, junk mail, cardboard, flatboard/paperboard

Needle Clipper Program



WCSWD provides *FREE needle clippers* for diabetic and home-based sharps users. District residents can pick up a free needle clipper at the Parke or Putnam County Health Department. Full clippers can be returned

to the health department to exchange for a new one. Needle clippers can also be dropped off at any WCSWD Tox-Away Day.

Yard Waste Drop-Off Site

Vegetative material such as grass, twigs, brush, and leaves are accepted at the Greencastle (Putnam County) Yard Waste Site. Yard waste is collected and transported locally for composting, mulching and/or erosion control. Tonnage varies and averages 40-50 tons annually. Free firewood when available.

Hours of Operation: (April-October) Mon. & Wed. 12-6 pm, and Sat. 9 am-3 pm. Closed on holidays. Nominal fees apply starting at \$1 per bag or \$1 per foot of truck bed/trailer; maximum of 14 feet. Residential use only due to limited space.



Christmas Tree-Cycling

Residents can recycle their "undecorated" fresh-cut Christmas trees Dec. 26 - end of January by dropping them off at one of the 4 collection sites (free of charge). These trees will give back to the Earth when used for fish and wildlife habitats, mulch, walking trail cover and/or to help prevent erosion.

"FREE" School Grants

Bench Grants (\$295 value)

K-12 public schools within the District are eligible to receive a **FREE 6' recycled plastic bench**! Students are engaged in collecting, weighing, and tracking 200 lbs. of plastic lids/caps and are rewarded for their efforts with a sturdy recycled bench purchased by West Central Solid Waste District to proudly display and enjoy inside or outdoors.

3R's "Reduce/Reuse/Recycle" Grants are available for K-12 public schools located within the District to start or expand a 3R's program. Items include paper recycling bins, can/bottle recycling bins, can crushers, worm compost bins, reusable water bottles, trays/dishes, and more. Schools incorporating reuse and/or recycling programs see a savings by reducing their need to regularly purchase single-use items, along with a reduction in trash disposal costs.

Electronic Waste Recycling

WCSWD sponsored its <u>12th annual</u> Electronic Waste (E-waste) Recycling Day at the Parke County 4-H Fairgrounds (Rockville); and the <u>3rd annual</u> E-waste Recycling Day in Putnam County at the Greencastle Middle School.

The Parke County event (June) collected **8,328 lbs. of electronics** and the Putnam County event (October) collected **2,800 lbs. of electronics** and safely removed these hazardous materials from local communities!



Tox-Away Day Collections

WCSWD sponsors one-day collection events for both counties annually, on Saturdays from 8am-1pm. In 2023, <u>834 vehicles</u> participated in the recycling and proper disposal of <u>77 tons</u> (an 8% increase over 2022 tonnage) of toxic/hazardous materials and problem wastes.

Tox-Away Days are the perfect opportunity to safely dispose of toxic, hazardous, and problem wastes such as:

- Appliances (CFC and non-CFC)
- Electronics/Televisions/Computers
- Tires (Car, truck, tractor, other)
- Automotive additives (fuel, oil, antifreeze)
- Oil-based paint, stain, varnish, paint thinner
- Mercury thermometers, fluorescent tubes/CFLs
- Pesticides, herbicides, fertilizer, poison
- Acids, bases, solvents, HH chemicals/cleaners
- Medication (non-controlled) and sharps

WCSWD continues to assist farmers with the high disposal costs of whole tractor tires over 54". The District paid \$65 of the \$90 per tire contractor fee. Farmers can also quarter these tires and recycle the first 2 free & pay only \$5 each for 2 additional tractor tires.
