This project goal is to promote understanding and awareness of gender alteration, its less known environmental factors, and challenges, particularly in faith based communities, and to uphold God's glory and bless others.

TYPICAL USES OF TERMS – Definitions and uses can vary

Hermaphrodite – a person with full male and female anatomy. This does not refer to sexual attraction or behavior.

Intersex – A newer wider term for a broad mix of anatomical body and brain variations. Most, not all, intersex people identify predominately male or female but possess a variety of characteristics of both genders. Not an "attraction" term.

Transgender.- Likely a subset of "intersex". Literally means "across gender" – describes someone who possesses an outwardly anatomical male or female lower body, but whose anatomical brain is mostly opposite. Toxin related hormonal disruption often can account for this dissonance between body anatomy and brain anatomy/function. There is more to discover. This category is often accused of mental illness or demon possession due to inadequate testing methods. "Transgender" is brain vs body anatomy and function, not attraction.

Gender fluid – a difficult transgender category in which traditionally stable functions become dynamic and the person's core gender changes or is fluid between male and female. It is not hard to suspect that an environmental influence (chemical, toxin) may be responsible for this category of gender alteration.

Agender – a transgender category in which the person is neither male nor female. Gender specific characteristics such as breasts may be very distressing to the person. Non binary is similar.

Attraction – Heterosexual - A person whose attraction anatomy is in sync with their body anatomy and they are attracted to the opposite sex is termed heterosexual.

Attraction - Same sex attraction - A person may be outwardly male, or female but their brain based "attraction" anatomy is to their same sex/gender, i.e., male attracted to male, or female attracted to female. Same sex attraction is not behavior, and same sex behavior should never be assumed. Environmental chemicals have been shown to interfere with male to female attraction and have created homosexual attractions in laboratory animals and in the wild. Terms include homosexual, gay, lesbian, bisexual.

Same sex behavior – commonly termed sodomy, is sexual behavior between persons of the same sex.

Cis gender – Typical, fully male and female persons in every category.

Cross dresser - This is a cis gender male or female, usually male, who for entertainment dresses in opposite gender persona and parades usually in a distant neighborhood. If they run into trouble they run back home to their suits and ties. They have no interest putting up with the social rejection endured by true gender altered people. However it is not unusual for true gender variant people to first believe they are cross dressers. Truly gender variant people, both children and adults, often privately cross dress to their true gender in an effort to relieve their dysphoria. This may continue for years, before they conclude they are actually intersex/transgender. A quote in the intersex community is that the difference between a "cross dresser" and an "intersex/transgender" is about 5 years (or 10 or ???)

Drag Queen – Drag queens are cross dressers who perform onstage for pay.

LGBTQIA – **Lesbian**= female to female attraction, **Bisexual**= both male and female attraction, **Transgender** = Opposite brain anatomy/identity to sexual anatomy, **Questioning** is just that, **Intersex**= a mix of male and female characteristics, formerly termed hermaphrodite, **Agender** =Brain anatomy/identity is neither male nor female.

Here are starter resources on 3 known causes of gender alteration. This list is by no means exhaustive.

1. Endocrine disrupting chemicals

Below is a key lecture by Dr. Warren Porter, U of Wisconsin, Madison. It is probably the best one lecture I have found for basic information on the effects of chemicals on our bodies and our children's development. It helps for lay persons to print the PowerPoint and sit down to listen with the slides in front of you. Later the lecture can be replayed over and over while in the kitchen, car, etc. until the more sciencey points are easier to understand.

Here is Dr. Vom Saal's call for a new risk assessment of BPA, see page 14 for methods corporate scientists used to hide the estrogenic effects of their chemicals, including using a special strain of rat (the Charles River Sprague Dawley rats) that was bred to be insensitive to the effects of the chemicals studied.

Endocrine disrupting chemicals include many pesticides and herbicides including RoundUp, atrazine, dioxins, DDT, many plastic additives including BPA, and BPA substitutes BPS, BPF and similar, phthalates, polycarbonates, artificial fragrances, sunscreens, dry cleaning chemicals, flame retardants, chlorine, fluoride, mercury and more.

2. Chimerism

Chimerism may occur when male/female twins are conceived and one dies early in the pregnancy. The living opposite gender twin may absorb and incorporate DNA from its deceased sibling. This may but not necessarily, cause the living twin to be both male and female. Here is a documentary on chimerism, (2 cases in this documentary did not cause intersex in the living twin. In the third case it did cause a child to be a chimeric hermaphrodite child) Also Sesquizygotic twins are a published phenomenon (NEJM)

I hope this helps and please feel free to stay in touch with more info to add to the pile, questions, comments, concerns. Included here is a list of claims, objections and arguments from Christians, mainly employed to exclude gender variant people from their churches and society. Some objections may be sincerely from ignorance, some fear based, some from misperceptions driven by spooky conspiracy theories or unrealistic pornographic perceptions of the gender variant community :-(. Perhaps some are afraid of the reactions of others who have not done their homework... Every concern is important to address as Christians try to navigate these disturbing developments in the light of the Word of God...

Two churches I know of that have deeply looked into gender variation are Mark Wingfield's Baptist church, and Stan Mitchell's GracePointe Nashville church. Google them. Both churches address both transgender and same sex attracted people. (They are not the same!) They now better understand the gender variation predicament. But they were unaware of the Missing Piece, endocrine disruption. I differ with both churches' conclusions on same sex marriage. (They subscribe to lifelong marriage commitment only.) On the other hand, I and many others support celibacy. However it is fair to hear these Christians' sincere explanations of the Scripture studies they have conducted on marriage. Videos on both sites present their painful and prayerful decisions based on their Biblical studies conducted WITHOUT KNOWLEDGE OF THE MISSING PIECE (endocrine disruption)) I repeat, at this time I am uncomfortable with those interpretations but recognize their sincerity.

Here are 4 new papers on Roundup that you should see.

I meant to say it is suspected that there is mammary tissues in male breasts in the Yaqui Valley children, who in puberty have large, very tender breasts. The girls do not have mammary tissue in their breasts, only fat. That was determined by palpitation.

Dear Olive,

I [am] happy to ... speak about neurological, endocrine and immune effects of pesticides. I would like to show ... some of the massive global changes that are occurring in each of those three categories and also educate ...about the potential threats of genetic and epigenetic modifications due to exposure to them.

The feminization or masculinization that can occur due to the two most common herbicides currently in use, roundup and atrazine, do not result in partial gender changes, but rather the whole body-brain and gonads are influenced by the balance of testosterone to estrogen (see the second slide) which is what can get shifted and lead to changes in sexual behavior. Tyrone Hayes has demonstrated this very well with frogs and Bruce McEwen showed how pseudo-estrogens can alter human sexual preferences in 1987.

Hope this helps you some.

Here are some scientific papers on issues of interest to you. By "whole body/brain and gonadal changes" I was trying to point out that sex hormones affect more than just the gonads' development. The sex center of the brain and its development can also be modified as Tyrone Hayes has shown for frogs and as Bruce McEwen has shown in people with his studies of diethylstilbestrol, a pseudo-estrogen.

Sex hormones are particularly important in affecting embryonic development and they are effective in the parts per trillion-parts per quadrillion range, as Fred Vom Saal has been shown in rats

.I am still teaching and researching full-time. Hope these papers help illustrate the breadth and complexity of low levels of chemicals in our bodies, especially during embryonic development.

Three Important Points to Be Aware of Regarding Gender Alteration Issues

Hyper machoism

Here is another important piece to understand particularly about Trans women.

In our society butch girls are accepted reasonably well as tomboys. However, effeminate males are despised, abused, even killed.

Therefore an actual boy who is misidentified as a girl will likely behave as a boy but folks will mistakenly consider him to be a female "butch" tomboy and he will not necessarily be rejected.

However, children who are actually girls, but who are misidentified as boys are often abused due to their feminine behaviors. They learn to try very very hard to be "boys" to avoid abuse and rejection. They may take on male projects, like fixing up a car, or enter professions that are male dominated such as first responders, carpenters, etc. This is called hypermachoism. Eventually in spite of their best efforts to be boys and men, these girl's true femininity may prevail and they may transition to their true female persona, much to the surprise and puzzlement of those around them, particularly if hypemachoism is a piece of the previous history.

Of course on top of these dynamics is also the truth that all these children are actually both female and male on a spectrum of degree, and it should not be a shock if they display some characteristics of both genders.

Brain anatomy/function("I am a girl", or "I am a boy") is a piece of gender that in most cases* is "set in stone". However, it does not always line up with lower body anatomy when disrupted by environmental toxins. We need to let these people tell us who they are!

* Exceptions to the above are "gender fluid" and "agender". Gender fluid is just that. The normally stable core brain anatomy function with regards to gender appears to flipflop, and is very difficult to understand. Even most intersex people respect but do not relate to gender fluid persons. Perhaps an environmental influence has influenced a normally stable unknown factor to become dynamic.

Agender people are also just that. Their brain anatomy/gender is neither male nor female, and does not match their lower body's anatomy. They may be distressed by gender specific physical characteristics such as breasts. Perhaps they can be accepted for who they are, and leave the gender piece out.

Bathroom issues

Family bathrooms or separate stalls or curtains in locker rooms seem safer for gender variant people since they have been beaten or killed in bathrooms. Most small businesses already have single stall family bathrooms and larger public facilities have the cash to install them or already have done so. This seems to be the best way to meet in the middle for both gender variant people and cis people.

Statistically, the gender variant community does not cause trouble in bathrooms. They do their business quietly and leave before they get hurt. They worry about the children in their community. Laws allowing gender variant people access to bathrooms according to their brain anatomy/igender are not as dangerous as many fear. These people have been there all along anyway, quietly doing their business, dressed in their core persona, so hopefully unnoticed. "Cis" cross dressers who are there to gawk have been there all along too, also intentionally blending in, so nothing is really changed. If a woman enters a ladies' room and finds a macho cowboy lounging around taking advantage of transgender laws, she at least knows to leave, or call for help if she suspects mischief. No one sends children into public bathrooms alone anyway, and cell phones may deter some crimes. Centuries ago, bathrooms were not segregated.

Understanding gender altered people and parents of gender altered children. These are important dynamics to grasp.

Many persons in this community may be hard to reach for Christ. They may have been rejected by churches and equate God with Christians whom they perceive wish to eliminate them. Therefore many may be abusive to anyone who mentions God. Christian "Trans" people may not understand why they are both male and female, simply that they are. The missing piece may explain a lot.

Adults and parents may be incensed by the suggestion that they or their child has a birth defect or is injured. They reason that there are more than 2 "traditional" genders because their chromosomes often vary from XX or XY, ex. XXY. Without knowledge of chemical mutation of genes, or endocrine disruption, they deduce that the God of the Bible is a fraud. ~ Among themselves, transgenders resent intersex/hermaphrodites because they have anatomical proof, which transgenders do not, have ~ Homosexuals accuse transgenders of merely being homosexual but trying to "get out of it" with the Trans label. ~ Trans people resent being included in the LGBTQIA label because their issues are not attraction based. ~ Cis people label transgenders "mentally ill" but may, accept provable intersex/hermaphrodite people. ~ Therefore to avoid social complications many gender altered people do not divulge their anatomical category amongst themselves or in online forums. Intersex/hermaphrodite people may refer to themselves as "transgender", meaning "across gender", even if they are intersex/hermaphrodite, to avoid accusations of "elitism" from the "both male and female"community.

Common claims, objections and misconceptions of gender altered people, particularly regarding church attendance, worship and communion

Category 1 - “Intersex” people with obvious external or internal anatomical alterations

Claim: Eunuchs of the womb are infertile men, not women, or hermaphrodites with birth or post birth alterations.

Response: God did not leave variant women out. He did not specify qualifications for a eunuch of the womb or eunuchs made by man to be exclusively male. Furthermore, gender variant persons *are* part male, and part female.

Claim: Scripture speaks of women bearing children and men producing seed. Therefore a woman must have a uterus. or she is a man. (Conversely must a man produce sperm. or he is a woman?).

Response: No, thanks to the fall in the Garden of Eden which introduced sin into the world, Sefect happen. Some women do not have a uterus (Mullerian agenesis), and some men cannot produce sperm or enough viable sperm. Many do not even know they are missing a uterus, or have a low sperm count, or other deviations until they are of reproductive age. However, they behaved and were considered male or female from birth. A boy, castrated in a circumcision accident was unwisely raised as a girl. He was still male, transitioned back to male and committed suicide. Nature trumps nurture.

Claim: Gender variant people are wicked perverts and categorically are not Christians.

Response: This false impression misunderstands “transgender”, and is straight out of choreographed transgender porn played mostly by “cis gender” actors, spooky conspiracy theories, and cross dresser misconceptions. How are Christians so influenced by transgender porn?? “Transgender/“intersex/hermaphrodite” terms do not refer to behavior, they define gender variations. There are gender variant people who are moral Christians. They know they are made in the image of God. Many Christians forget to accept this Scriptural concept.

Claim: Gender variant people should accept their lot in life without gender related treatment.

Response: Why? No one else does when medical treatment is available to at least relieve suffering and deformity such as cleft palate, heart defects, hormone imbalances, illnesses or injuries. Their desire to live in one persona, the one they “are”, or most closely are in brain anatomy/function is Scriptural. One of many reasons they wish to complete to their true persona is the contempt and scorn they endure from society due to their naturally effeminate or butch behaviors in the wrong gender. Christians punish these victims harshly mostly to justify their own disturbed responses.

Claim: There are no intersex people (meaning male/female). They are always one or the other as God made us.

Response: God made us male and female, before sin, but the devil and man’s fraudulent science did not. God foresaw intersex alterations and made provision for the eunuch without further specification. He covered both “in utero” and “post birth” injury. However most gender variant people “are” mostly one gender or the other and wish to live in that persona. This is an inborn Scriptural desire that paradoxically, many Christians reject for the victims.

Claim: Do not consider science because science changes. We can only rely on Scripture.

Response: Science is God’s creation in all its detail. Sin *can* change God’s scientific handiwork. Sin and wickedness in corporate chemical labs has done this. To conveniently rule out science is to rule out respect of God’s handiwork. Intersex people are fact. They are observable science, still created by God, and Scripture addresses them. Human scientific *theory* does change. Knowledge of the process of intersex injuries does change as more is discovered. Respect for the horrific observable scientific changes that chemicals can cause is Scriptural and needs attention, not avoidance, especially in churches as they serve souls.

Category 2 – “Transgender” i.e. intersex people with opposite brain vs. body anatomy/physiology

Claim: Gender is *only* determined by sex anatomy below the waist. Sexual anatomy below the waist always matches brain gender anatomy/function. If someone claims otherwise they are mentally ill or demon possessed.

Response: Endocrine and DNA disruptors that mix up DNA, hormones, and anatomy have disrupted our previously obvious delivery room indicators, i.e. sexual anatomy. However gender related anatomy/physiology has always been both below the waist (sexual) *and in the anatomy of the brain (gender)*. The pineal, pituitary and hypothalamus glands in the brain are part of gender anatomy and function, although the specific location of gender awareness is not known. Particularly in the “female brain/male body” anatomy mismatch there are explanations for this variation. Typical children in utero with male DNA receive a flood of testosterone to their brain when newly formed testicles begin secreting testosterone about week 8. This changes their brain from “pink” to “blue”.* If an estrogen mimic chemical or other interference disrupts that process, the child’s brain or parts of it, may remain “pink”. Many chemicals are estrogen mimics and can interfere with this process. People with female brains and male bodies are found in all walks of life, in many respected, educated positions. They are not mentally ill; their perfectly good female brains just don’t match their body. They are miserable, often abused due to effeminate behaviors and may commit suicide. * See Dobson’s article <https://www.dobsonlibrary.com/resource/article/d582579a-c379-4784-a393-bd6739c8becf>

Objection: Transgender people are demon possessed and are deceived that they are opposite gender.

Response: This simply is not true in most cases. Demon possession is real and anyone can be influenced by a demon but it makes more sense that an environmental factor has caused the child’s brain anatomy and body to develop out of sync. Churches have tortured and abused variant children under the mistaken impression of demon possession or harassment. Perhaps the demonic deception is from use of the church’s chemicals, not the child.

Objection: If children are misgendered at birth they should accept the mistake made by doctors and parents and live out their lives in that gender. (This keeps everyone around them comfortable and them often suicidal.)

Response: This smacks of a spooky conspiracy theory that claims that illuminati and elite people intentionally transgender their children at birth or in the womb as a satanic practice, leaving them both genders or opposite to their cis birth. This supposed practice would be considered evil by most faith based communities and is unlikely as this is a miserable choice. However, when a child truly is misidentified at birth these same religious people try to insist that the kids accept their mistaken gender for life. The misgendered child is considered demon possessed or unworthy of worship to think otherwise. That is double talk. While there may be real ritual wickedness going on in some satanic covens, parents can’t successfully force a child’s gender, although they can time conception to favor one or the other in some cases. A child’s gender is outside of the parent’s nurturing control.

Claim: If an intersex person has procreated somehow in one gender or the other, they are that gender regardless of any other factor and must live as such in order to worship God.

Response: This is hard for everyone to perceive. Many gender variant people have previously tried to fulfil societal expectations of marriage and procreation in their mistaken gender, sometimes reluctantly, with help of science. They are still parents of their children, fathers or mothers, but in these cases parenting does not necessarily define their true gender. Scripture does not teach such. A hermaphrodite/eunuch woman who somehow fathered children is still not a man. She is a hermaphrodite woman. To force her to live as a man does

not make her a man, it forces her to transition opposite herself, which is abusive, perverted, and unscriptural. Or vice versa. In today's new world of disrupting chemicals, girls can father children, and boys can bear them.

Objection: Satan's goal is a genderless society, against God's plan for male and female. To agree to "transgender ideology" is to fall in line with Satan's wiles.

Response: Agreed, it is obvious Satan has a genderless society, in mind. He is using chemicals and environmental influences to accomplish this goal and Christians are busy filling in the blanks for him with insistent and indiscriminate use of chemicals. Churches should have nothing to do with these immoral substances and be an example and a haven as possible from them for their babies, children, teens, reproducing parents and older members. They should care for the victims as best as is known and support them to live beloved and accepted lives of moral significance and honor among us as stated in Isaiah 56:4, 5.

Note: Endocrine disruption does not just affect gender. It affects all the glands including thyroid, reproduction, bone growth and can cause breast cancer and other neuroendocrine cancers and conditions. Everyone is susceptible to its devastation. Chemicals also mutate genes as in Down's syndrome, gender DNA mix-ups (XXY, XXYY), etc.

Objection: Transgender people are by definition immoral, perverted homosexuals or worse and must be spurned.

Response: This is a misunderstanding of terms. Transgender/intersex people in a variety of ways are both male and female. "Transgender" is a gender category, only. It does not refer to sexual attractions or behaviors. Many moral faithful transgender Christians have been kicked out of their churches due to these false ideas. Why only pick on transgender morals? How about ourselves, our pedophilic priests and pastors, or immoral heterosexual neighbors and coworkers?

Question: If a person is both male and female who should they marry??

Response: For many, perhaps God intends them to be celibate and devote their single lives to his service? Some wonder if they can marry an opposite intersex person? Best for them to ask God if or who they should marry.

Claim: (This claim only regards "same sex attraction", not transgender) "Same sex attraction" is a willful sinful choice and such people must repent and change their attractions to heterosexual.

Response: Sexual attraction is not sexual behavior. They are separate. Many same sex attracted people's inborn *attractions* are disrupted *beyond their control to change them*, often by endocrine disrupting chemicals. Since Scripture seems clear that same sex *behavior* is forbidden under any condition, celibacy may be their only moral option. (Some Bible scholars disagree.) There are cases in which prayer, counselling, detoxing or antiparasitical treatments have helped some reorient to heterosexual attractions. NOTE: Some heterosexual people choose to *behave* homosexually. They must repent of this abomination and return to God's moral order.

Claim: Gender variant young people (hermaphrodite/intersex/transgender) and same sex attracted young people (homosexual) should be subjected to "conversion therapy" in order to turn them from their "delusions".

Response: Conversion therapy consists of tying a same sex attracted young person down and forcing them to watch pornographic scenes of homosexual behaviors while torturing them, including cutting, etc. The theory is that they will associate those behaviors with pain. This is abominable and is against the law. Similar torture of transgender children (sometimes in church basements!) is meant to drive out the "demons" that deceived the child. How much better for a church to repent of the unintentionally immoral endocrine disrupting chemicals they

sprayed on the church lawn that the child and his parents before him played on, tracked into their home on their shoes, and may have consumed in the same church basement dining room!

Objection: Gender altered people may not worship due to their persona transition regardless of their morality.

Response: In Isaiah 56:1-8 God repeatedly clearly expects morally living gender altered eunuchs and other nontraditional outcasts to worship Him in His House and within the walls of His temple. He specifically mentions the honored place/momument and everlasting name eunuchs are promised. Gender variant people are all male (and female).

Objection: Many Christians deny that chemical and environmental endocrine disruption explain transgender.

Response: True, and they refuse to hear, or heed, Scripture, science, and warnings. They expose church members and children to endocrine disruptors at social events, and in lawn and facility maintenance, then reject victims of these same chemicals. Church policy influences are reflected in homes, schools, businesses, parks, and on farms. These Christians have said "Raca" to other intelligent brethren who were more careful with chemicals and toxins than themselves. They scornfully trashed the social lives of quiet "luddite, health nut" brethren with disdainful, superior contempt, and drove others from choosing a safer lifestyle. Now that these substances have proven so horrific, it is hard to humbly acknowledge the damage done. God help us repent, apologize, *forgive*, put away these substances, and comfort the injured. God is a God of mercy, grace and forgiveness for us all! We can be grateful.

* **Raca** vain, empty, worthless, only found in [Matthew 5:22](#) . The Jews used it as a word of contempt. It is derived from a root meaning "to spit."

Concern: Gender altered people are not welcome in many churches, period.

Opposite concern: The gender and attraction variant community is white to harvest for the gospel, but is not only avoided but publicly attacked by Christians. Paradoxically, great lengths are taken to bring the gospel to criminals, whores, pedophiles, prisoners, homeless drunkards, thieves, pagans, etc. But gender altered or same sex attracted people are unwelcome in many churches, not sought with Good News, and perceived unsafe with kids.

Response: Many in the gender and attraction variant community do wish to attend church, and study the Word. Rejection hurts them extremely. They are already suffering and are terribly sensitive. They are often turned away from Christ by the hypocrisy of Christian leaders who reject "them" but then cover the tracks of their own immoral Christian friends. Many gender variant people are bitter to Christians and hard to reach for Christ due to Christian's support of Christian organizations promoting agendas to eliminate them.

Churches need to understand these people AND gender variant people need assurance that Jesus Christ is the One Who will never leave them nor forsake them. They can trust Him.

Regarding children's safety, ALL children should be morally Scripturally trained and supervised whether in the company of family members, cousins, pastors, priests, in young people's activities, at retreats, camps, conferences, school, etc. Many Christian children and young people have experienced immoral sexual encounters at church and family sponsored events. Dear Lord, help us be vigilant in our protection of those with whom God has entrusted us. Gender variant people, contrary to popular misperceptions, do not have a notable record of pedophilia.
