3. **VISITORS/CITIZEN INQUIRY:** In accordance with the Open Meeting Act, EDC members are prohibited from acting or discussing (other than factual response to specific questions) any items brought before them at this time. This is reserved only for items NOT covered on the agenda. No formal action can be taken on these items at this meeting. Discussion is limited to five (5) minutes per person.

ACTION ITEMS: All the following items on the Action Agenda are discussed by the EDC board and will be individually enacted upon with a motion.

4. **Discuss, consider, and take action with John McElfish/Grant Works and presenting other information gathered about the water system to set a plan in motion as to what the EDC could contribute to the City of Trinidad to improve the water system.**
5. **Discuss, consider, and take action on any suggestions, plan of action, determination of any ideas that would enable the EDC to contribute financially to the City of Trinidad water issues.**
6. **Discuss, consider, and take action on hiring the former city attorneys, Knight Law Firm, LLP to represent the Trinidad EDC.**
7. **Discuss, consider, and take action on bids received from contractors for the mowing the of the EDC land on Highway 31.**


