CREDIT APPLICATION - TERMS

ACCOUNT AGREEMENT

- 1. Charges are payable according to the terms stated on HRH invoices unless otherwise agreed in writing.
- 2. Past-due balances may be assessed a late charge of 1.5% per month (18% annually), or the maximum permitted by applicable law, whichever is less.
- 3. Applicant agrees to pay reasonable collection costs and attorney fees incurred in collecting past-due amounts to the extent permitted by law.
- 4. HRH may establish, change, suspend or withdraw a credit limit at its discretion. Applicant remains responsible for all purchases charged to the account.
- 5. Claims for damaged, incorrect or non-conforming goods should be reported promptly. Returns and credits are subject to HRH approval and return policies.
- 6. Electronic completion and electronic signatures may be accepted as originals to the extent permitted by applicable law.
