## Privacy Policy Notice

We are committed to safeguarding customer information;

### PURPOSE OF THIS NOTICE

- Information that we receive from others, such as an escrow company, title company, real estate appraiser, real estate agent, property inspector, surveyor, notary, attorney, county recorder, or any other person or entity that has been deemed a participant in your transaction with us.

Unless it is specifically stated otherwise in an amended Privacy Policy Notice, no additional nonpublic personal information will be collected about you.

We may disclose any of the above information that we collect about our customers or former customers to our affiliates or to non-affiliated third parties as permitted by law.
