The District will consider and act upon the following matters:

Presentation of financial report and review and act on financial matters, including financial reports, financial condition of the district investments, depositories and other accounts, audits, Investment Policy, bank depository pledge agreements, and payment of the District's bills, including approval of commissioner fees and expense reimbursements.

  - b. Ambulance Report
  - c. IT Service Report

  - a. Discuss Budget Items.
  - b. Discuss and review Sales Tax Election Committee.

- c. Discuss and or adopt a Delinquent Tax Collection Resolution for delinquent taxes for tax year 2025 and subsequent years. (Hand Out)
- d. Resolution for Designating the Tax Office/CAD to help with property tax setting. (Hand Out)
