Notice is hereby given that VAN ZANDT COUNTY EMERGENCY SERVICES DISTRICT NO. 2 will hold a meeting on **June 9, 2026**, at **2:00 p.m.**, at the following location in the District: **318 N. Saline Street, Grand Saline, Texas 75140.**

The District will consider and act upon the following matters:

1. Call meeting to order, roll call and establish a quorum.
Announcement by the presiding member whether a quorum is present, that notice of the meeting was posted for the time and in the manner required by law, and that the meeting has been duly called to order
2. Invocation and Pledge of Allegiance.
3. To approve the Minutes of prior meeting(s).
 - a. May 12, 2025, regular public meeting
 - b. May 12, 2026 Tax Election and Budget Workshop meeting
4. To receive public comment.
Public participation is limited to the designated portion of the meeting. Anyone wishing to speak must complete a form provided and include the topic they wish to speak about. The board may impose reasonable restraints if deemed necessary. Time will be limited to 3 minutes per speaker.
5. To review, discuss and act on financial matters.
 - a. Presentation of financial report and review and act on financial matters, including financial reports, financial condition of the district investments, depositories and other accounts, audits, Investment Policy, bank depository pledge agreements, and payment of the District's bills, including approval of commissioner fees and expense reimbursements.
6. To receive and review Department reports.
 - a. Fire Department Report
 - b. Ambulance Report
 - c. IT Service Report
7. The Following Will Be Discussed, Approved/Accepted/Rejected, Or Tabled for Further Study:
 - a. Discuss Budget Items
 - b. To review and act on matters relating to an election to be held November 3, 2026.

1) Approve an Order of Election under Texas Health and Safety Code sections 775.0751 and 775.0752 to call for an election to impose a local sales and use tax not to exceed 2% at any location in the District.

2) To review and act to contract with Van Zandt County Elections Office for election services.

3) To review and act to approve holding the election jointly with other jurisdictions.

4) To review and take any other actions necessary to hold the election.


c. To review and act to engage consultants to assist with community education regarding the District, including the possible sales tax election

13. To discuss and confirm the next regular monthly meeting date as well as any items that need to be on the next meeting agenda.
