Annual Fee Information:

If the annual fee is not settled in full by **31 January 2026** the payment option automatically defaults to the 12 monthly option and the discount will no longer apply.

Payments:

- The school fee payments may be made annually or monthly in advance on or before the **first of every month**.
- Recurring payments (such as debit orders) are required to streamline monthly fee collections.

The selected payment plan must apply consistently across all 2026 registrations, including Tuition, Aftercare, and Music. For example, if you choose to pay tuition monthly, Aftercare and Music fees must also follow a monthly payment plan.

Outstanding Fees:

If fees are in arrears, the school reserves the right to take the necessary steps as per the conditions of the contract.

Notice Period:

The school requires 90 days' written notice in the event of a parent wishing to deregister a student. Should sufficient notice not be given, parents will be held liable for 90 days' tuition fees.

Sibling Discount:

A sibling is one of two or more students currently registered at a school within the Advtech Schools South Africa Brands, having one or both Parent/Guardians in common.

Applicable Discount:

If two or more siblings are registered within the same school brand concurrently, in the same academic year, each sibling from the 2nd sibling onwards will qualify for a discount on the current academic year's tuition fees (excluding all other service fees) based on the following rules:

Sibling Ranking	Discount %
Sibling 1	0%
Sibling 2	5%
Sibling 3	10%
Sibling 4 onwards per sibling	15%
