
Vehicle Mitigation

- ▶ Rated by calculating the impact rating of a barrier to stop a vehicle
- ▶ Calculation uses the weight of the vehicle, the speed at which the vehicle is traveling, and the distance traveled
 - Types of barriers
 - Passive Barriers (fixed)
 - Fixed Bollards
 - Planters / Landscaping
 - Concrete Barriers
 - Active Barriers (Operable / Temporary)
 - Bollards that raise or lower into the ground
 - Gates
 - Drop Arm Barriers



Traffic Mitigation

- ▶ Designed to manage traffic flow and secure areas by not allowing unauthorized vehicles
- ▶ Ratings: Don't always need a vehicle mitigation rating
- ▶ Types of barriers
 - Concrete / Tread barriers
 - Water filled barriers
 - Type 1,2, or 3 barriers



Emergency Response

- Create Emergency Response Plans for both event times as well as all other times that don't include events
- Work closely with local and federal emergency responders to create the procedures
- Command Center
 - A fully operational Command Center is run 24 hours a day
 - Who operates within that Command Center is determined by event time vs nonevent time



Key takeaways:

Own your system:

- Ask for as-builts
- Have regular backups
- Maintain key system, biting matrix, records
- Don't be held hostage, open platform or keep in mind potential migration

Maintain it:

- Plan for maintenance and upgrades, 7-10 yrs lifespan
- Mechanical locks need lubrication and adjustments
- Batteries need replacing, like fire systems
- Log into it periodically, learn to use it

Vendors:

- Find someone you trust and build relationships
- Not all systems are created equal, ask for details, various scenarios
- Ask about ongoing fees or other "hidden" charges
- Online costs for equipment is misleading (turnkey is not wholesale)
- Ask your peers if you suspect price gouging or other issues

Why is Risk Mitigation & Security Important?

Legal Duty: Colorado Premises Liability Act – C.R.S. § 13-21-115

Real estate owners and facility managers owe a duty of care to individuals on their property, categorized as invitees, licensees, or trespassers...managers must exercise reasonable care to protect against dangers they knew or should have known about. This includes maintaining safe conditions and addressing known hazards promptly.

Legal Definitions:

- *Invitee: Someone who is invited onto the property for business (e.g., a customer).*
- *Licensee: Someone allowed on the property for non-business reasons (e.g., a social guest).*
- *Trespasser: Someone who enters or remains on the land without the landowner's consent.*



Physical Security - Active & Passive

Environmental Design

- Warning signs
- Fencing
- Bollards, barriers, and posts
- Eliminate hiding places
- Site lighting
- Vehicle height restrictions

Access Control

- Keypads
- Access cards/fobs/apps
- Biometrics



Intrusion Detection


- Motion sensors, door/window contacts, etc.

Video Monitoring

- Might not catch someone “in the act”
- Video can help identify the person(s) responsible

Functions of Countermeasures and Controls

There are **seven** things that a security control can hope to achieve



Deter

Make asset a less attractive target.



Control Access

Keep the asset out of reach.



Detect

Discover a harmful event happening.



Delay

Slow progress or impact.



Assess

Identify needed action.



Respond

Interrupt or reduce impact.



Record

For incident for follow-up.




Cybersecurity Breaches

Cybersecurity breaches expected to increase worldwide in all sectors

Energy, finance, technology and manufacturing are high-risk targets

Projected increases in cloud environment intrusions/cloud-conscious cases

Increase in Generative AI-related attacks around KPI logistics

Ransomware/malware/data breaches (abuse of valid credentials) most common attacks

Manufacturing sector most targeted

Personal Cybersecurity Best Practices

Use a *passphrase*:

!AdelynIsMySw33tLittlePrincess42!

Enabling two-factor authentication (2FA)

Lie on security questions:

- *Where did you go to high school?*
Farmville
- *In what city was your first job?*
Cleveland

A personal hotspot is much safer than public Wi-Fi (coffee shops, airports, hotels)

Avoid introducing yourself to unknown callers.
“Hello?” instead of “Hello this is Chris.”

Risk Mitigation Strategies

- **Implement Surveillance Systems:** Install security cameras around the property to deter criminal activity and assist in investigations if incidents occur.
- **Enhance Lighting:** Ensure that parking lots and building entrances are well-lit to discourage unauthorized access during nighttime hours.
- **Access Control:** Utilize keycard systems or security personnel to monitor and control entry points to the building.
- **Community Engagement:** Participate in local neighborhood watch programs and maintain open communication with local Police Department for updates on crime trends and safety resources.
- **Employee Training:** Provide training for staff on safety protocols, emergency procedures, and how to report suspicious activities.
