

Warranty Statement Cush Single Point FabFlex

Limited 5 year WARRANTY INFORMATION: PLEASE REVIEW PRODUCT-SPECIFIC COVERAGE BELOW.



Valid warranty claims will be covered for parts and labor as follows:

- · Replacement of warrantable parts will be replaced, repaired or reimbursed at the discretion of Cush.
- Warranty claim must be approved by Cush prior to warranty repair or replacement of components.
- The approved reimbursement of any parts are limited to the suggested list price.
- Warranty applies to non-wearable structural parts.
- Coverage of labor will be based upon standard repair times (SRT's) by Cush per regional labor rates.
- All claims must be submitted within 60 days of repair, by submitting a Cush warranty claim request form with pertinent information such as serial number, trailer manufacture date, etc. All failed components must be held for potential review by, or submission to, Cush for inspection and evaluation. Any freight costs for components requested by Cush must be paid by the claimant, and will be reimbursed for valid claims.

Exclusions and Limitations:

- Warranty will not apply to improperly installed units or parts by other than Cush.
- Any use, repair or modification of Cush model that is not in accordance with Cush recommendations, applications and normal usage will void warranty.
- Lack of reasonable and proper maintenance.
- Warranty is limited to the original owner.
- In no event shall Cush be responsible for incidental claims including, but not limited to items such as accidents, abuse, personal injury, downtime, towing, and cargo loss.
- Wearable components such as trunnion tube, bushings, & end pads may have specific warranty coverage.
- Damage resulting from corrosion.
- · For vehicles that operate full or part time outside of the United States and Canada, a 1 year/unlimited parts only warranty may apply.

General Disclaimer of Warranty: This warranty is in lieu of all other warranties or conditions, expressed, implied or statutory including any implied warranty of merchantability or fitness for particular purpose. Any items or conditions not covered in this warranty will default to the Cush Corp general warranty (P0202-01) for Trailer Suspensions. To be able to process your warranty claim we need a warranty job sheet specific to Cush Corp warrantable items only, RMA. An invoice or job sheet with only Cush warranty items allows us to clearly interpret and review you claim in a timely manner. A warranty invoice with items or labor not the responsibility of Cush Corp may be denied for those items. Warranty allowances are given as standard repair times, the most important thing to get proper warranty approval is upfront communication with Cush about labor and parts needed to complete the repair.
