#### Notice of Rate Increase to Accommodate County Disposal Fee Adjustment

Dear Valued Customer,

We appreciate your continued trust in Rubatino Refuse Removal for your waste collection and disposal needs.

We are writing to inform you that your service rate will increase on January 1, 2026 to accommodate an increase in the fee Rubatino pays to dispose of your garbage at Snohomish County transfer stations that will become effective the same day. This adjustment reflects only the disposal fee increase from Snohomish County which is charged to all regulated solid waste collection companies. Below are some examples of the anticipated approved rates:

32 GAL	\$8.49	\$10.54
48 GAL	\$20.69	\$23.10
64 GAL	\$23.99	\$26.83
96 GAL	\$30.20	\$34.24

The UTC has the authority to set final rates that may be higher or lower than our requests, depending on the results of their examination. # FEES INCREASING JAN. 1, 2026

Snohomish County Solid Waste services are primarily funded through tipping fees paid by curbside haulers and customers at transfer stations and drop box sites. As the cost of managing approximately 670,000 tons of garbage each year continues to rise, a fee adjustment in 2026 is necessary to maintain the high level of service and operations our community relies on.



#### Why are fees increasing?

This is the first widespread fee increase since 2009 while the rate of inflation during that time has exceeded 45%; the division used property sales and implemented various operational efficiencies to subsize rates for years to avoid increases to customers.

#### Available at no charge:

- Recycling services at transfer stations and drop boxes
- Household Hazardous Waste disposal for residential customers

#### Date new fees take effect?

Jan. 1, 2026

### What is changing?

Tipping fee for self-haul at transfer stations	\$105/ton	\$160/ton
Disposal fee at drop box sites	\$20/cubic yard	\$30/cubic yard
Vactor waste disposal	\$567/load	\$598/load
Hard to handle waste	\$200/ton	\$250/ton
Unsecured load	\$5 or \$10 depending on type of vehicle	\$20 or \$25 depending on type of vehicle
