HOW CAN I HELP?

Make your ASF contribution this week (March 23-29). **If your family participates, you will earn 5 free dress down passes.** The ASF is a tax credit program administered by the State of Ohio that costs you nothing while directly benefiting St. Joan of Arc School with your tax dollars. **Yes, you read that correctly - it costs you nothing!**

ANYONE WHO PAYS OHIO TAXES CAN DO THIS!

Parishioners, school families, grandparents, aunts, uncles, friends, coworkers — you don't need a child at the school, and you don't need to be Catholic. **Forward this onto everyone you know.** Their participation is key to our success. Note: Check line 8c on your 2024 Ohio IT 1040 for your tax liability. If the total on line 8c is more than \$750 (individual) or \$1,500 (married filing jointly), you may contribute the full amount and claim the full tax credit. If it is less, you can still contribute the amount shown and claim the credit.

WHERE DO I CONTRIBUTE?

ASF IN UNDER 60 SECONDS

Ohio lets you redirect up to \$750 (or \$1,500 for married couple filing jointly) of the state income tax you already owe — straight into scholarships for St. Joan of Arc School students and families.

You contribute to the ASF online now **[before filing your taxes]**, then claim a dollar-for-dollar Ohio tax credit when you file for 2025.

If you get a refund, it gets bigger. If you owe, it shrinks what you owe.

Net cost to you: \$0.00

Money for SJA School: \$750-\$1,500
