Heat Pump Systems

REBATE	SEER2	HSPF2	EER2
TIER 1: \$500	15.2+	7.8	11.0
TIER 2: \$1,000	16.0+	7.8	11.0
TIER 3: \$1,400	18.0+	7.8	11.0

Additional \$250 on a dual fuel heat pump (hybrid) - Efficiency must meet or exceed Tier 1 level above.

Central Air Conditioning Systems

REBATE	SEER2	EER2
TIER 1: \$500	15.2+	12.0
TIER 2: \$900	16.0+	12.0
TIER 3: \$1,200	18.0+	12.0

Mini Split Heat Pump Systems

REBATE	SEER2	HSPF2	EER2
Single Zone (one head): \$250	17.0+	8.5	12.0
Multi Zone (per head): \$200	17.0+	8.5	12.0

SEER = Seasonal Energy Efficiency Ratio

HSPF = Heating Seasonal Performance Factor

EER = Energy Efficiency Rating
