#### Definitions and interpretation

  - b. References to sub-clauses, clauses, schedules, or appendices are to be sub-clauses, clauses, schedules or appendices of this privacy policy.
  - c. A reference to a person includes firms, companies, government entities, trusts and partnerships.
  - d. "including" is understood to mean "including without limitation".
  - e. Reference to any statutory provision includes any modification to amendment of it'
  - f. The headings and sub-headings do not form part of this privacy policy.



### Scope of this privacy policy

2. This privacy policy applies only to the actions of W. F. Clayton & Co Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
3. For purposes of the application Data Protection Laws, W. F. Clayton & Co Ltd is the “data controller”. This means that W. F. Clayton & Co Ltd determines the purpose for which, and the manner in which your Data is processed.

### How we collect Data

4. We collect Data in the following ways:

### Data that is given to us by you

5. W. F. Clayton & Co Ltd will collect your Data in a number of ways, for example:

### Data that is collected automatically

6. To the extent that you access the Website, we will collect your Data automatically, for example:
  - a. We automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

### Keeping Data secure

7. We will use technical and organisational measures to safeguard your Data, for example:

### Data retention

11. Even if we delete your Data, it may be present on backup or archival media for legal, tax or regulatory purposes.

### Your rights

12. You have the following rights in relation to your Data:
- a. **Right to access** – the right to request (i) copies of the information we hold about you at any one time, or (ii) that we modify, update, or delete such information. If we provide you with access to the information, we hold about you, we will not charge you for this, unless your request is “manifestly unfounded or excessive.” Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reason why.
  - b. **Right to correct** – the right to have your Data rectified if it is inaccurate or incomplete
  - c. **Right to restrict our use of your Data** – the right to “block” us from using your Data or limit the way in which we can use it.
  - d. **Right to erase** – the right to request that we delete or remove your Data from our systems.
  - e. **Right to data portability** – the right to request that we move, copy or transfer your Data.
  - f. **Right to object** – the right to object to our use of your Data, including where we use it for legitimate reasons.

19. In the above instance, we will take steps with the aim of ensuring your privacy is protected.

### General

20. You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where we reasonably believe your rights will not be affected.
21. If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that the provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
22. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
23. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
