Itemized Selection of Services

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy an item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Services of Funeral Director, staff and overhead \$ 1590.

Our fee includes, but is not limited to funeral home staff to respond to the initial request for service; arrangement conference with the family or responsible party; preparation and filing of necessary authorizations and permits; recording vital statistics; shelter of remains, preparation of obituary notices, coordination with those providing other portions of the funeral, e.g., cemetery, clergy, florist, crematory, and others as necessary. Also included in this charge are overhead expenses relative to our facility such as professional licensing fees, legal and accounting fees, building and vehicle insurance, utility expenses, grounds maintenance, taxes, equipment, furnishings, inventory costs, secretarial and administrative expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee or a portion thereof, is already included in our charge for direct cremations, immediate burials, and forwarding or receiving of remains).

Embalming – Professional Care and Preparation \$ 585.

Embalming is not required by law. Embalming may be necessary, however if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or an immediate burial.

All accounts are due in full at the time arrangements are made.

We offer the following payment options:

1. **Cash or Check.**
2. **Credit Card** – Visa, MasterCard, American Express and Discover.
3. **Insurance Assignment** – Payment with assignment of a Valid and Verified Insurance Policy. We do not accept policies that cannot be verified. We do not accept contestable insurance policies issued within two (2) years of death or work-related insurance that cannot be assigned.
4. **Prepaid Funeral Trust** – We accept prearranged, prepaid funeral plans written through Chavez Funeral Home. If the Prepaid funeral plan was not paid in full, the outstanding balance can be paid via option 1 or 2. On a case-by-case basis, we may honor a prearranged funeral trust written by another funeral home.
5. **Payment Plan** – Our payment plan is financing through, LENDINGUSA.COM. **Lending USA** offers payments for qualified individuals on a 3-year and 5-year payment plan.
6. **A Finance Charge** of **2%** (Two Percent) per month, **24%** (Twenty-Four Percent) Annual Percentage Rate will be applied to all unpaid accounts after 30 days.
7. **Any family** that has failed to pay previous accounts to Chavez Funeral Home whether verbal or written will be required to pay such accounts in full before any services or merchandise will be supplied by this firm.
