### Purpose of Courtesy Hold

Courtesy holds are intended for short-term circumstances that temporarily prevent training, such as extended travel, temporary work obligations, or other significant schedule disruptions.

---

### 1. Courtesy Hold Request

Krav Maga Israeli may approve a **temporary one-month membership courtesy hold** for members experiencing short-term schedule conflicts such as travel, work obligations, or other temporary circumstances.

Approved hold periods begin on the **first day of the month** and last for **one full calendar month**.

### 2. Courtesy Hold Terms

#### 2.1 One Courtesy Hold Per Membership Term

Members may receive one courtesy hold per membership term.

#### 2.2 Membership Extension

The membership agreement will be **extended by one additional month**, equal to the approved hold period.

#### 2.3 Billing During Hold

Membership billing will be **paused during the approved hold period**.

#### 2.4 Participation During Hold

Members **may not attend classes or participate in training activities** while their membership is on hold.

#### 2.5 Automatic Reactivation

Membership billing and training privileges will automatically **resume at the end of the hold period**.

## 2.6 Request Notice Requirement

Courtesy hold requests must be submitted **at least 10 days prior to the next billing cycle** to take effect on the first day of the following month.

Requests submitted after this timeframe may take effect on the **next eligible billing cycle**.

### Example

Request submitted **February 18** → **Hold begins March 1**

Request submitted **February 25** → **Hold begins April 1**

## 2.7 Retroactive Holds

Courtesy holds cannot be applied retroactively. **Membership payments are non-refundable, and missed or unused time does not qualify for refunds, credits, or extensions.**

## 2.8 Cancellation Notice

Courtesy holds **do not replace or shorten any required cancellation notice period** outlined in the membership agreement.

## 2.9 Hold and Cancellation Policy

A membership hold does not replace or satisfy the cancellation notice requirements outlined in the membership agreement.

If a member chooses to cancel their membership following a hold period, the required cancellation notice period will still apply and must be submitted in accordance with the terms of the membership agreement.

## 2.10 Policy Exceptions

Krav Maga Israeli understands that unforeseen circumstances may occur. Any exceptions to this policy are granted solely at the discretion of management and must be approved in writing.

## 3. Medical Holds

Krav Maga Israeli understands that medical situations may arise that temporarily prevent participation. Medical holds may be considered under the following conditions:

### 3.1 Active Membership Requirement

Medical hold requests must be submitted during an active membership period.

### 3.2 Duration

Medical holds are limited to a maximum of one (1) month and follow the same structure as standard courtesy holds. Additional time may be considered at management's discretion for serious medical conditions.

### 3.3 Documentation

Medical documentation (such as a physician's note) may be required to approve a medical hold.

### **3.4 Approval Requirement**

All medical holds must be approved in advance by Krav Maga Israeli, LLC.

### **3.5 Retroactive Requests**

Medical holds, credits, or extensions cannot be applied retroactively. **Medical circumstances do not qualify for refunds and are addressed through approved medical holds only.**

### **3.6 Expired Memberships**

Memberships that have expired are not eligible for holds, extensions, or reinstatement of unused time.
