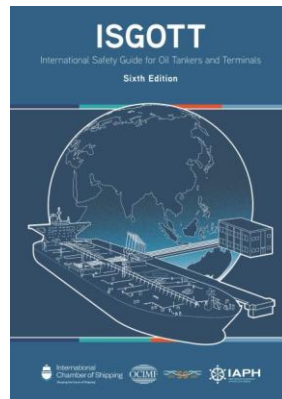

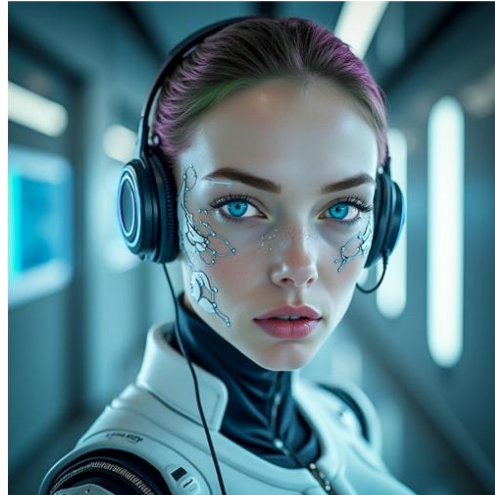

As you may know, in June 2020 the 6th edition of the International Safety Guide for Tankers and Terminal was published, replacing the 5th edition of 2006. In 15 years much has changed about the ship/terminal interface concerning HSEQ. Different views by experience have been developed into updated rules, guidelines and regulations world-wide.

The new Ship/Shore Safety Checklist (SSSCL) should be implemented and used from January 01, 2021 onwards. What we strongly recommend you to do is to train and instruct your staff who are responsible for the ship/shore interface about how to use it and to understand all the questions in the context of the latest 2020 ISGOTT edition.

This new checklist consists of various parts that should be understood in relation to Part 4 on the Management of the Ship/Shore Interface focusing on *communication and information sharing*. As you can see, each question includes a referenced subject/chapter number: for

example question 1. Pre-arrival information is exchanged (reference: 6.5, 21,2). Our training method consists of reading, discussing and explaining each reference.
