New Zealand employers who want to hire a Filipino worker may be required to meet certain Department of Migrant Workers regulations, including registering with a Licensed Recruitment Agency in Philippines, and for foreign workers to be issued with an Overseas Employment Certificate (OEC) before travel to New Zealand. Stellar Immigration Services can assist employers in meeting these requirements. The fees below include the DMW application fee.
