## FOR CERTIFICATE OF APPROPRIATENESS

The City of Pewee Valley Overlay District Commission meets on the last Thursday of each month at 3:00 PM in the Town Hall, 312 Mt Mercy Drive Pewee Valley, KY. Applications must be submitted to the Pewee Valley City Clerk's Office at the above address. The applicant's request will be reviewed only if all required information and appropriate exhibits listed in the checklist below are included with the submittal. Submissions must be received not less than 14 calendar days prior to each scheduled monthly meeting to ensure adequate time for review and public notices. Applicant's attendance at the scheduled meeting is required for approval to be granted.

Reference City of Pewee Valley Ordinance #7, Series 2022 regarding the establishment of the Overlay District Commission and administration of Overlay Districts. A certificate of appropriateness from the Commission shall be required before a person may undertake the following actions affecting the exterior of any property located within a designated overlay district: (a) Construction requiring a building permit; (b) Demolition requiring a demolition permit; (c) Relocation or moving a structure; and (d) Any project requiring a development plan approval, conditional use permit or site disturbance permit.
