Clubs were created to give youth a home away from home, and we truly believe that now is the time to build the infrastructure to expand our physical footprint so that no child gets turned away. With a working goal of approximately \$10 million, the Boys & Girls Club of Las Cruces Building Great Futures Capital Campaign will focus on renovating and expanding the former Video 4 property located at 1005 El Paseo Rd. The renovation and expansion project will provide a STEM lab, dedicated art room, theater, recreation room, and more. Additionally, the increased square footage will allow us to serve three times more Club kids on a daily basis.

In 1965, Boys & Girls Club of Las Cruces made the long-term move to what many know as the old Presbyterian Church on Las Cruces Avenue. Since then, the facility has been a home away from home to tens of thousands of youth. Although the facility has never compromised our ability to deliver our mission, at just over 6,800 square feet, it continues to limit the amount of youth we can provide consistent daily services to. Moreover, a building of this age undoubtedly brings on multiple challenges including frequent costly repairs and the lack of infrastructure needed to provide the technology and tools that are imperative for young people to achieve 21st-century success.

For years, we have dreamed of welcoming Las Cruces kids and teens to a brand-new, state-of-the-art facility. This new facility will allow us to triple the amount of youth we are able to serve, fulfilling the same mission we have always worked for – building great futures for young people, but in bigger, more meaningful ways. As we plan for the future, we have met with local leaders to ensure our location makes sense for generations of Club kids to come. The new facility is part of a city-wide initiative to revitalize the El Paseo corridor. Plans for the 30,000-square-foot facility include:

- A state-of-the-art STEM lab
- A full-size gymnasium
- A separate wing for teens
- Spaces focused on the arts

OPPORTUNITIES TO MAKE A DIFFERENCE



There are many ways you can invest in Building Great Futures. All gifts of \$500 or more will be recognized on permanent donor recognition signage in the lobby of the new facility.

Make a pledge. Make a gift to the campaign, pledged over a one to three-year giving period. You may choose to satisfy your pledge through monthly, quarterly, or annual payments, or customize your own payment schedule. You can satisfy your pledge through payments by check, direct deposit, or credit card. We gladly accept Visa, MasterCard, Discover, and American Express. And we will be happy to send you reminders of pledge payments as they become due.

Make a gift of securities. Gifts of highly appreciated assets, such as stock with a very low basis, make excellent charitable gifts. By donating stock, you avoid costly gains and significantly help Las Cruces youth at the same time. We will be happy to assist you in transferring assets to complete your gift.

Make an in-kind gift. Boys & Girls Club of Las Cruces will consider all kinds of “other than cash” gifts such as real estate and personal property. We are happy to visit with you about potential in-kind gifts.

Special Tax-free IRA gifts. For those 70 1/2 or older, it is now possible to make tax-favored charitable gifts from traditional and Roth IRA accounts. A total of up to \$105,000 per year can be transferred directly from traditional or Roth IRAs to one or more qualified charities such as the Boys & Girls Club free from federal income tax. Amounts given in this way count toward required IRA minimum withdrawal amounts for the year of the gift. To make such gifts, it is important not to withdraw funds prior to a gift, but have the gift amount distributed directly from an IRA to the organization. Check with your tax advisor for more information.

Make a planned gift. For some donors, a planned gift—or other type of deferred giving arrangement—may better suit your financial and planning needs. These can be structured through a variety of vehicles, including a bequest in a will, a trust arrangement, and other income-producing vehicles such as life insurance and annuities. In considering a planned gift, it is best to consult your tax, legal, and financial advisor(s). We will be happy to work with you and your advisor(s) to structure a gift that best suits your tax and real estate planning needs.

Remember no gift is too small to make a difference for our communities youth!
