
Emission Reduction Targets

We are committed to reaching net zero emissions by 2050, a reduction of 100%. We are aiming to bring our net zero target forward in future years based on our ability to meet interim targets. We also aim to set additional ambitious short and medium term targets in following years.

Short term target: Reduce the Scope 1 emissions associated with our fleet vehicles by 27.3% by 2027, bringing our total footprint down by 23.44% from 2023.

Long term target: Net zero emissions by 2050.

Carbon Reduction Projects

- A majority of our emissions are associated with our fleet vehicles, categorised as Scope 1 mobile combustion emissions. In order to reduce this, we are currently committed to decarbonising our fleet by phasing out petrol and diesel in favour of electric vehicles. In 2023, we acquired our first electric vehicle. We will purchase three additional electric vehicles to meet our short term goal of reducing our scope 1 emissions by 27.3% by 2027.
- We have committed to installing solar panels on our premises in 2024 to reduce our reliance on low-carbon utilities tariffs. This will ensure that our scope 2 emissions remain low in future years.
- We are integrating data tracking and monitoring practices with our environmental policy to improve the accuracy of emissions data in subsequent years. We will work closely with our suppliers to ensure that relevant data is captured across our value-chain. This will facilitate further Scope 3 reductions by providing insight into emissions associated with upstream transportation and distribution.
- We are committed to reducing our waste impact. Currently, none of the waste handled by our waste partner goes to landfill. We will work closely with our waste partner to explore options for reducing the carbon intensity of this process as well as reducing the overall volume of our waste.
- We will engage with our staff to find ways to further reduce emissions associated with employee commuting, potentially through a Cycle to Work scheme.
