Thank you for your Entry into the 2026 CTHS Manitoba Yearling Sale!

The sale will be on **THURSDAY, AUGUST 20th** held at our Sales Pavilion located on the Assiniboia Downs Backstretch. Following is a list of general information for sale consignors. If you have further questions regarding the sale, please contact the CTHS office @ 204-832-1702.

CONSIGNOR INFORMATION

1. The fee for each yearling consigned to the sale **by May 29th/26 is \$236.25** (\$225 + \$11.25 gst). If nomination is postmarked **after May 30th, the fee is \$446.25** (\$425 + \$21.25 gst) per yearling. **Late nominations will be accepted but must be received by June 15 or delivered in person by June 15.** Nominations will not be accepted postmarked or delivered after June 15.
2. All thoroughbred yearlings are eligible to enter this sale.
3. PLEASE **SIGN THE CONSIGNORS CONTRACT. SEPARATE CONTRACTS ARE REQUIRED FOR EACH INDIVIDUAL OWNER OR PARTNERSHIP.**
4. Consignors must forward Coggins papers to the CTHS office by Friday August 14th. Yearlings entered in the sale are required a **Negative Coggins test within 6 months of the sale**
5. Consignors must forward vaccine **EHV1(influenza) and EHV4** (rhinopneumonitis) verification to the CTHS office by Friday August 14th. Vaccines must be given no more than **100days** out of the sale.
6. Forward **ORIGINAL** Jockey Club Digital Certificates with attached Canadian registration papers **by Friday August 14th**. If you haven't checked the markings on the registration papers against the yearling, now would be the time to do so. Corrections can be made free of charge within 6 months of the issue date (see bottom right corner of registration papers). After 6 months, The Jockey Club charges \$80. This cost will be passed on to you if the yearling is sold with incorrect papers. The CTHS office will charge \$35 to process paper corrections for yearlings sold at the sale.
7. For each horse consigned and presented for sale, regardless if the horse is sold or receives a bid, a minimum **commission of \$100 or 5% of the highest bid** or the reserve price whichever is greater, will be paid to the CTHS by the consignor.
8. Yearlings accepted to the sale and subsequently withdrawn by the consignor without a veterinary certificate will be charged a **\$350 (per entry) withdrawal fee.**
9. Yearlings will be accommodated in a specified barn, situated on the Assiniboia Downs backstretch. All Yearlings must be on site by **Tuesday August 18th 5pm.**
Arrival times: **Monday, August 17th 11am- 6pm. Tuesday August 18th 11am- 5pm**
****PLEASE DO NOT TAKE YEARLINGS OUTSIDE DURING ASD TRAINING HOURS AND DURING TUESDAY AND WEDNESDAY RACE NIGHTS.**
10. Stalls will have 4 bags of **shavings** prior to the yearlings' arrival. However, subsequent bedding, hay, water, water buckets, feed buckets and stall cleaning will be the consignors' responsibility.
11. A listing of stall allocation will be posted near the entrance of the Sale barn.
12. The Sale barn area will be closed to consignors at 10:00 P.M each night, with security beginning at that time.
13. The Sale barns will be open for yearling **viewing beginning Wednesday, August 19th at noon- 4pm and commencing Thursday August 20th at 10 am** Consignors are advised to clean stalls prior to the viewing period and to have personnel on hand to show the yearlings.
13. **Leather halter** with parentage plate will be **provided**. Consignors will be billed **the halters at COST.**
14. Consignors are responsible for delivering yearlings to the Sale ring on schedule, then back to the stabling area immediately following bidding.
15. **Consignors** are responsible for **feeding and watering** the yearlings the **entire time** they are stabled in the Sale barn, including after they return from the sale ring.
16. The shipping-out of yearlings can begin immediately following the (their) Sale. **Option to ship out on Friday August 21st between 11am-2pm. All stalls must be vacated by 2pm on August 21st.**
