A Message Regarding Our CEO:

Dynamic Federal Credit Union Board of Directors would like to announce the retirement of CEO, Diane Rodriguez effective May 2024. Diane joined the credit union as CEO in 1996 when she left her 16-year banking career to lead the credit union when it was known as Celina Reynoco Employees Federal Credit Union. At that time, the credit union had \$2 million in assets with 1,200 members and three employees. Under Diane's leadership, the credit union experienced strong growth, became a community-chartered credit union, and rebranded as Dynamic Federal Credit Union.

Dynamic FCU now serves more than 6,100 members with more than \$64 million in assets with 19 employees. This growth reflects the credit union's mission to improve the quality of life and banking services for our members. Diane is honored to have led Dynamic FCU to live its "purpose" by empowering its employees, members, and the community to live their best lives.

The Dynamic FCU Board unanimously appointed Member Service Vice President, Danelle Chesser as Rodriguez's successor, with her full support. Chesser officially took the reins of CEO on January 1, 2024. Danelle joined the credit union in 2010 and has advanced from teller, new accounts, loan processor, administrative assistant and most recently VP of Member Services.

The Board would like to thank Diane for her leadership, passion, and commitment to Dynamic FCU and our members. We have full confidence that Danelle is the right person to lead Dynamic FCU into this next chapter and we know members, employees and the community will continue to be supported by Dynamic FCU for generations to come.
