



## 25 Year Limited Galvalume® Warranty

### COVERAGE

MAC Metal Sales, Inc. extends this warranty to panels, effective from the date of shipment and sold as a warranted or Number One Warranty Galvalume® panel as indicated on the customer's original invoice. It applies only to goods used on wood frame buildings and on architectural, commercial, pre-engineered or residential metal buildings, which are installed in the United States of America. This warranty shall extend to the purchaser of the material and is non-assignable and/or non-transferable. Should the Purchaser become insolvent, bankrupt, make an assignment for the benefits of its creditors, or for any reason discontinue its normal or regular business practices, this warranty shall forthwith become null and void and of no legal effect. The purchaser must present the original sales receipt and any other records necessary to identify proof of purchase for warranty consideration.

### TERMS

MAC Metal Sales, Inc. warrants that the goods covered by this warranty will resist natural weathering to the extent that they will conform to the performance standards listed below during a period of twenty-five (25) years provided that all conditions of this warranty are first met.

1. For a period of twenty-five (25) years, the panel(s) will not rupture, fail structurally, or perforate due to exposure to normal atmospheric conditions.

### EXCEPTIONS

This warranty does not apply to panels exposed at any time to corrosive or aggressive atmospheric conditions, including but not limited to:

- o Areas subject to water run-off from lead or copper flashings or areas in metallic contact with lead or copper
- o Areas subject to salt water marine atmospheres or to constant spraying of either salt or fresh water.
- o Conditions/circumstances where corrosive fumes or condensates are generated or released inside the building.
- o Areas subject to fallout or exposure to corrosive chemicals, fumes, ash, cement dust, or animal waste.

This warranty does not apply in the event of:

- o Mechanical, chemical, or other damage sustained during shipment, storage, erection, or after erection.
- o Failure to provide free drainage of water, including internal condensation from overlaps and all other surfaces of the sheets or panels.
- o Failure to remove debris from overlaps and all other surfaces of the sheets or panels.
- o Damage caused to the metallic coating by improper scouring or cleaning procedures.
- o Deterioration of the panels caused by contact with green or wet lumber, or storage stain caused by water damage or condensation.
- o Presence of damp insulation or other corrosive materials in contact with or close proximity to the panel
- o Deterioration to the panels caused directly or indirectly by panel contact with concrete, asphalt, gravel, dirt, mulch, or any corrosive material.
- o Deterioration to the panels caused directly or indirectly by panel contact with fasteners. Selection of suitable long-lasting fasteners to be used with Galvalume® roofing and siding panels rests solely with the Buyer.
- o A degree of bending less than 2T for sheet gauges up to .030 in. and degree of bending less than 4T for sheet gauges .031 in. and thicker.
- o Slopes of roof or sections of the roof flatter than ¼" : 12.
- o Non-uniform surface appearance, including, but not limited to, variation in color, sheen, and spangle.

### REMEDY

This warranty shall be subject to the stipulations, limitations, and conditions hereinafter set forth:

- o This warranty shall be interpreted and enforced in accordance with the laws of the state of Kentucky, USA, without regard to principles regarding conflicts of law, the courts of which State shall have exclusive jurisdiction and venue over the enforcement of this warranty. There is excluded from this warranty the application of the United Nations Convention on Contracts for the International Sale of Goods.
- o This warranty is contingent on the proper maintenance of the building, which maintenance is to be provided by the building owner.
- o Seller's liability for breach of this warranty and/or for the failure of material to conform, whether due to Seller's negligent acts or omissions or otherwise, shall be limited exclusively to the cost of either repairing nonconforming panels, or at Seller's sole option, of furnishing (FOB Seller's plant) sufficient panels to replace nonconforming panels.
- o Seller will be responsible for replacement of material only. Seller shall not in any event be liable for the cost of labor expended by others on any nonconforming material or for any special, indirect, or consequential damages to anyone caused by the nonconforming material.
- o Seller reserves the right to terminate this warranty at any time (except as to orders already accepted) upon the giving of written notice thereof.
