

Until recently, this beloved comic was syndicated in thousands of newspapers across six continents and published in forty-eight different languages! It was a delightful show produced by our local Starlight Theater at Rock Valley College.

This annual event provides every attendee with a Dilly Bar from Dairy Queen, a Goodie Cup filled with tchotchke items and candy, and free popcorn, cookies and water. New this year, the Rockford Police Department sent out their K9 unit to demonstrate the powerful & dynamic force a K9 presence brings to the Rockford Police Department. It may not have been Snoopy out there running down the barrels but it was "Snoopy the Red Barron" approved!

Each year, the Good Samaritan Fund serves an average of 30 residents, providing ongoing and personalized care to those who have outlived their financial resources. # Conversations with our Chaplain.

As we are continuing to navigate through all the twists, turns and turbulences of this present life, let us hold fast to this one unfailing fact – God is good and His love is everlasting! God is good when life and our health are not. He is good when our finances or family may not be. And God is good when people are not. Yes, God is good when situations in our lives are not.

In Psalm 107:1-9, the Psalmist gives three key insights to encourage us to keep flowing and following in the goodness of God. First, we must always give thanks to the Lord for who He is and the blessed redemption He gives us (vs 1-2). We must live in God's goodness even when our situations are not so good (vs 3-7). And furthermore, be still and know that God's goodness fulfills our lives (vs 8-9).

Biblical scholar Dr. J. Clinton McCann Jr., states the following about the goodness of God: "...we would do better to think of God as the vulnerable victim, or at least on the side of the vulnerable and victimized. God is not causing the pain, but rather God is sharing the pain and empowering people to endure it. God is not orchestrating the tragedy, but rather God is sharing the grief and preparing people to live beyond it. God is not creating natural disasters, but rather God is suffering with the victims and motivating people to respond with compassion and generosity. Why? Because God is good, and God's faithful love lasts forever!" We pray your hearts are encouraged, that you continually show kindness to others and that you always put your trust in the Lord. Remember Jesus is the King of Kings who cares for us, covers us and showers us daily with His abiding goodness and faithful love. Our God is Good!

You'll notice a fun article about a group of neighbors who get together every morning to share in the Pledge of Allegiance. It provides a way of staying in touch and encouraging each other doing during this pandemic. Speaking of the pandemic I am happy to share with you that vaccination rates at Wesley Willows and Peterson Meadows are extremely high with over 98% of residents vaccinated and 88% of all staff vaccinated. These numbers are above national averages for Senior living communities. Wesley Willows does not require employees to be vaccinated, but rather encourages that they do. For those who are not vaccinated, they are tested weekly for Covid and are not eligible to return to work without a negative test result. This has been a successful effort in terms of keeping our residents in

healthcare as safe as possible as well as trying to keep all of our INDISPENSABLE WARRIORS safe and free from COVID-19.

In closing, it was a joy for me to read the article on our Volunteer Extraordinaire, Gail Holtzman. You will enjoy how Gail has become very active in the Wesley Willows community and has a heart for our mission, our residents, and our staff.



The last 18 months have certainly been a roller coaster ride when it comes to the stock market. Now, the market is up, we wanted to take the opportunity to share some valuable information with you.



If you have your shares of stock in a brokerage account, this is a convenient way to transfer your securities. Simply instruct your broker to electronically transfer your securities out of your account into Wesley Willows *Charles Schwab* account at *Focus Financial*.
