

## **Pet Care/Boarding/Sitting/Walk/Daycare Agreement**

Time and Payment. Pet Sitter shall care for Pet Owner's pet(s) as identified and described below

Payment is made in consideration for Pet Sitter's care and services and paid via cash or Venmo

Full payment is due a day before first day of service. (If payment is not made on Venmo app same day of walk time, an additional charge of \$15 daily will be added to the sum payment. (With the exception of bank holidays and weekends that are taken into consideration)

Product Services: In case pet runs out of food or medications or any other supplies. Pet parent must pay \$20 shopping fee as well as cover any costs of product to replenish supply. This will be addressed to Pet Parent before it takes place. Please make sure you pack extra supplies to avoid this.

Cancellation Policy: Pet Owner must notify Pet Sitter before 2 weeks before service start date for cancellation. Full amount of service will still be due to the length and complexity it usually takes to attempt a possible last-minute fill-in with another client into an advanced reservation spot. Reservations are usually requested at least 2 weeks or more in advance and are saved reservation spots for such requested dates.

1. Precautionary: Pet Owner agrees to reimburse Pet Sitter for care, services provided by a Veterinarian if need be, Emergency food if needed, plus extra charge for any additional regular days or nights outside of regular service.
2. . Care and Services. The care and services provided under this agreement consist of the following responsibilities:

Walk dog for length of service time, pick up poo, send photos, return dog home and lock door,

send dog report and photo of mapped walk at end of walk.

Boardings/Daycare include potty breaks every hour. 1 to 2 20 min walks depending on length of stay. (Longer walks will cost extra upon request). Playtime, feedings if needed with food provided by Pet Owner.

3.. Emergencies. If there is an emergency, Pet Sitter will make all reasonable efforts to first contact Pet Owner. If Pet Owner is unable to be contacted, Pet Sitter shall contact the following:

In addition, Pet Owner authorizes Pet Sitter to seek and obtain medical attention and treatment as deemed necessary by veterinarian. Pet Owner agrees to allow Pet Sitter to take pet(s) to any available emergency/veterinarian if regular veterinarian is not available.

- 4. Injury and Identification. If pet(s) described in Section 3 accidentally dies, becomes ill, injured, or lost, Pet Owner waives and releases Pet Sitter fully from any and all claims arising from such incident. If the pet(s) bites or injures Pet Sitter, any other human or animal, Pet Sitter will first go through active insurance through Pet Care for the damages, if there are any remaining leftover charges insurance won't cover the Pet Owner will be responsible for. Pet Owner shall not hold Pet Sitter against any and all costs, expenses, losses, liabilities, and claims arising out of or relating to any acts of the pet(s) except if arising out of the negligence or intentional misconduct on the part of the Pet Sitter. Pet Owner will be contacted immediately if anything went wrong with their pet, whether if it was a behavior, injury, or observed health concern.

5. Abandonment. Pet Owner agrees to the following: If Pet Owner fails to respond to Pet Sitter within 12 hour period, neglects picking up pet, Pet Sitter will then proceed to contact emergency contacts on file. If they too fail to respond in said above timely manner, then Pet Sitter claims right to rehome pet(s) and Pet Owner will be legally held fully financially responsible for any fees charged by shelters and additional time spent with Pet Sitter.

6. Governing Law: The terms of this Agreement shall be governed by and construed in accordance with the laws of the State of Oregon, not including its conflicts of law provisions.

7. Severability. If any provision of this Agreement is held to be invalid or unenforceable in whole or in part, the remaining provisions shall not be affected and shall continue to be valid and enforceable as

though the invalid or unenforceable parts had not been included in this Agreement.

8. Entire Agreement and Amendment. This Agreement contains the entire understand between the Parties and supersedes and cancels all prior agreement of the Parties. This Agreement may be amended or modified only by a written agreement signed by all Parties.
