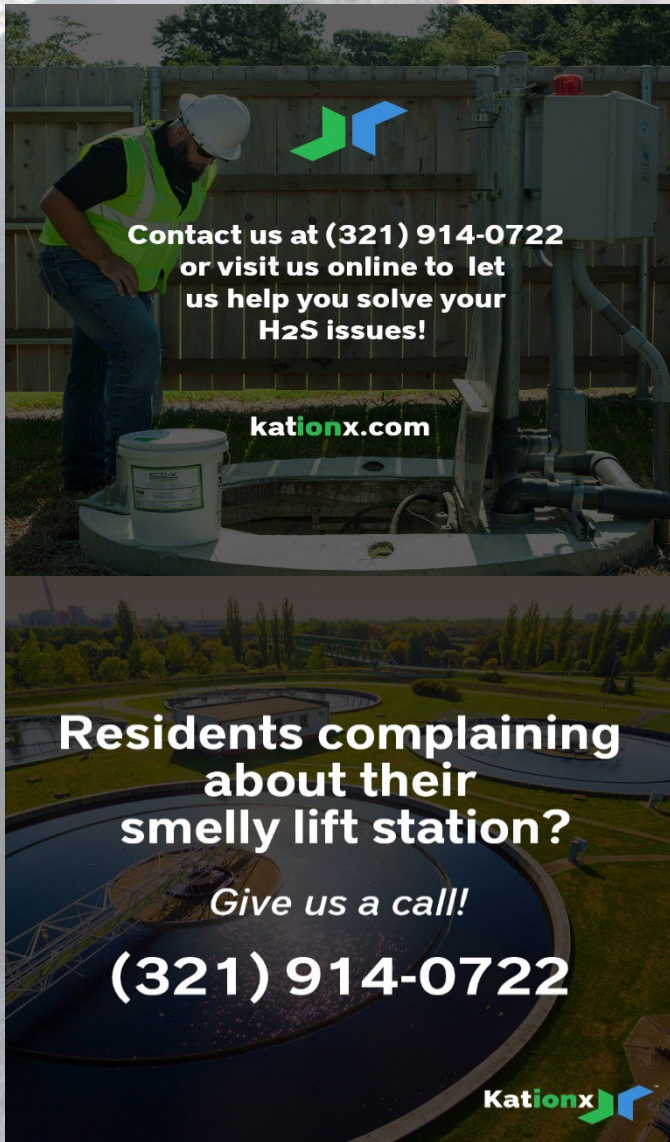

User Instructions:

1. **KCDX** removes FOG, odors & reactive molecules.
2. Shake **KCDX** powder directly on mats. Otherwise shake powder into inlet waterfall or trowel to distribute evenly across well's surface water. This dust is important: It provides maximum surface area, efficiently consuming reactive molecules.
3. Jet in water or **KCDX** emulsion to mix **KCDX** with FOG mats & wastewater.
4. After 5-10 minutes of jetting/mixing, then pump the well down. Scavenging odors & FOG removal continues downstream.

Dosage:

For initial treatment dose of 1-2 buckets every week for 3-4 weeks. Then maintain with dosing bi-weekly (and eventually, maybe only monthly). With routine use, persistent presence builds inside the infrastructure.

For moderate to heavy solid FOG. A high-water pressure hose is best when adding water.

Other Uses:

KCDX can also be used at SSOs to remove odor and consolidate escaped wastewater. Forms an effective matrix that's very easy To clean up (*it won't kill the grass!*).

Safety:

KCDX is safe-to-handle. Rinse with soap & water to remove from skin or eyes. If swallowed, drink water or milk to flush/rinse (It's non-toxic). Wear dust mask to avoid breathing dust. Slip & fall hazard on wet surfaces.
