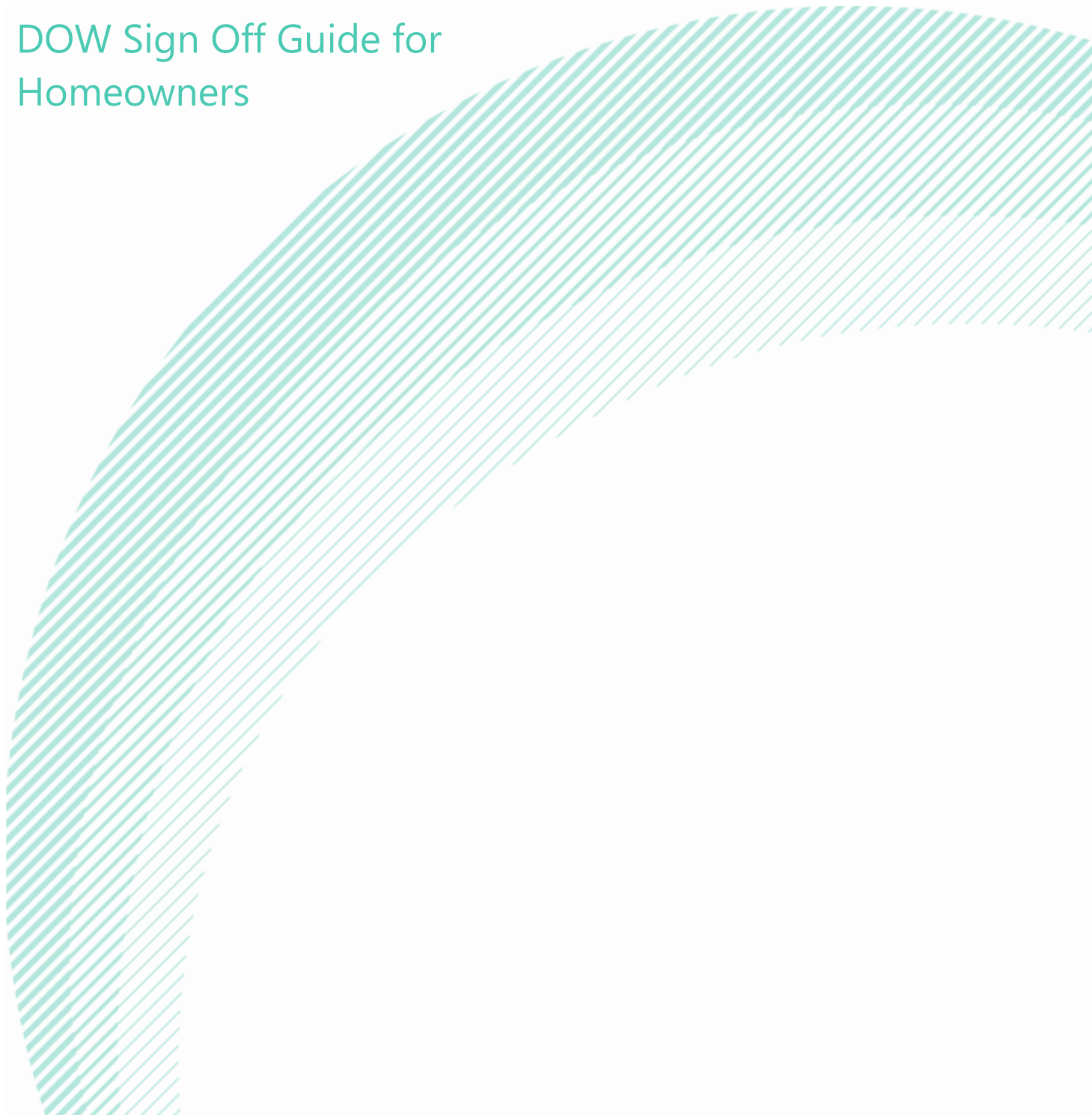

DOW Sign Off Guide for
Homeowners



Declaration of Works (DOW) form Guidance

A significant number of Declaration of Works (DOW) forms submitted for processing result in being returned to the Homeowner due to the form being filled out incorrectly or not to completion. The most common reason for the returns of these documents is the absence of a signature from either the Homeowner or Contractor.

Please note for every application, the Homeowner must supply their signature on all sections, where requested, in order for the Declaration of Works form to be processed and proceed for grant payment subject to all terms and conditions being met.

The three forms where the Homeowner must fill out and supply their signature are as follows:

- 1. The Request for Payment Form**
- 2. The Declaration of Works (DOW) Form for each measure applied.**
- 3. The Declaration of Works (DOW) Form for the Post-Works Building Energy Rating (BER)**

The next page shows where the Homeowner must fill out and sign each form to meet the requirements.
