Chairman Riched Sileo proposed a motion that RESOLVED, that the Board of Finance recommends that the Town of Thomaston appropriate an amount not to exceed \$111,000 from the Town's Undesignated Fund Balance to hire DRA to perform a feasibility study of the facility usage and regionalization potentials to assess and provide recommendations on the educational and operational efficiency of Thomaston Public Schools, and to authorize the First Selectman to take all actions and execute all documents necessary or convenient for said purpose.
