Failure to return this form signed by both the owner and non-owner resident carries a **MINIMUM \$25.00 fine**.
- **Termite Inspection** is scheduled for Monday, February 16, 2026. This inspection will be an **exterior inspection only unless one of the following conditions occurs:**
1. The owner of the unit specifically requests an interior inspection **in advance** by calling Palm Pest and Lawn at 1 352 592-8484 or emailing Palm Pest Office at [office@palmpestandlawn.com](mailto:office@palmpestandlawn.com).
  2. The technicians see evidence of termite infestation from their exterior inspection.
