Camping: \$375 **Primitive Camping:** \$100

Reserved Parking: \$30 per site, limit 1 per family, located just inside gate 1 (limited passes available, first come first served)

Campgrounds Reserved Parking: \$50, located in the marked grass in the campgrounds (limited passes available, first come first served)



2026 Fair Reserved Parking rules (by gate 1 & near the campgrounds):

- Available to purchase for \$30/\$50
- Provided parking pass must be displayed on rear view mirror
- Must enter through Calumet gate entrance and follow loop around to fenced in area!
- Only permitted to exit gate 1 and follow in traffic direction on one way road
- Any vehicle without a permit displayed is subject to being towed (at owner's expense)
- No assigned parking spots
- Limit of 1 pass per family
- Any unsold lots will be first come first served after noon on Saturday prior to fair start
- Park in designated areas only.

Must be 18 (MB18) PARENTAL ESCORT POLICY

Must Be 18 years old from 4 PM to close. Parental escort policy must be followed

To ensure the safety of all who attend the fair, anyone under the age of 18 entering after 4:00pm must be accompanied by an adult who is at least 25 years of age. Each adult over the age of 25 may supervise up to four (4) youth, and must remain with them at all times while on the grounds.

Visitors are expected to carry acceptable proof of age. (i.e., photo ID with date of birth. This includes: drivers license, state ID, military ID, college ID, passport or visa)

Full face coverings that prevent identification are not permitted.

Montgomery County Agricultural Society By-laws & Constitution – ARTICLE V – Election – Section 9

To run for Montgomery County Board of Director, you must:

1. Submit a BCI background check with your petition prior to being considered as a candidate. Reimbursements for candidates will be processed after a passing background check is received, the candidate has won the election, and with submittal of reimbursement form
2. Attend four (4) Fair Board meetings in the year you are running for director.
3. Completed ten (10) volunteer hours in the year you are running for director.

All Petitions must have the above documentation included upon submission to the Secretary of the Society. Any member of the Montgomery County Agricultural Society in good standing may declare his/her candidacy for the office of Director by filing with the Secretary of the Society, a petition signed by ten or more members of the Society. Blank petitions for this purpose shall be obtained from the office of the Fair Management, 580 Calumet Lane, Dayton, Ohio 45417, starting Monday, June 15th, 2026 and returned by July 1st, 2026.

The Annual Meeting and Election of Directors by ballot by resolution of the Board has been fixed as Friday, July 17th, 2026, 3:00pm-7:00pm and will be announced three (3) weeks prior thereto in the public press of Montgomery County, or by notification by mail to each member of the Society.

Newly elected Directors will take office at the November, 2026 Meeting.

2026 FAIR GOLF CART RULES

Dear Campers & Fair Attendees,

1. **Campsite Requirement-** Golf carts are only permitted for those with a registered campsite during the 2026 fair. Only one cart per campsite is allowed
2. **Golf Cart Specifications-** Carts must have functional lights and a standard manufactured exhaust. A horn is recommended. Only standard golf cart motors are permitted
3. **Insurance Requirement-** You must provide proof of \$100,000 liability insurance listing golf cart on the policy. A certificate of liability must name the following as additional insured:

4. **Driver Eligibility** – Drivers must be at least 16 years old, possess a valid driver’s license, and be covered by the cart owner’s insurance.
5. **Registration Deadline** – All golf carts must be registered and have insurance by July 1st, 2026.
6. **Permit Fee** – A \$50.00 fee applies for golf cart use from **July 14-19, 2026**. Payments must be made via check or money order to MCAS.
7. **Restricted Areas** – Golf carts are only permitted in the campground, livestock trailer parking, and designated golf cart parking. They are not allowed on the fairgrounds or access roads.
8. **Rule Enforcement & Penalties** – The Montgomery County Sheriff, Security, and Fair Board will strictly enforce these rules. Violations will result in immediate confiscation of the cart, which will be held at the Sheriff’s building until the fair ends. No warnings will be issued. You may also lose camping privileges.
9. **Permit Display** – A registration sticker must be clearly displayed on the front or windshield of the golf cart for visibility by the Sheriff and Fair Board. Copying a permit is strictly prohibited.
10. **No Rentals Provided** – The MCAS does not rent golf carts. You must arrange your own rental through a dealer.
11. **Passenger Limits** – The number of passengers cannot exceed the number of available seats. One person per seat.
12. **Seated Riders Only** – All passengers must remain seated at all times while the golf cart is in motion.
13. **No Alcohol or Drug Use** – Operating a golf cart under the influence of alcohol or drugs is strictly prohibited under Ag Society rules and state law. Possession or consumption of alcohol or drugs while operating a cart is grounds for arrest.
14. **Safe Operation Required** – Careless driving or any behavior that endangers others or property will not be tolerated.
15. **Lost Permit Policy** – Lost permits will not be replaced. If your permit is lost, your golf cart will not be allowed on the grounds.



ANY VIOLATION OF THE ABOVE RULES WILL RESULT IN BEING ASKED TO LEAVE THE CAMPGROUNDS IMMEDIATELY AND/OR LOSING YOUR GOLF CART AND CAMPING PRIVILEGES. DECISION AND THE DURATION OF LOST PRIVILEGES WILL BE DETERMINED BY THE BOARD OF DIRECTORS OF THE MONTGOMERY COUNTY AGRICULTURAL SOCIETY.

2026 FAIR CAMPING RULES

***Reminder – Hours to bring in your camper are

Friday, July 10th from 3pm to 8pm and Saturday, July 11th from 8am to 8pm and Sunday, July 12th from 8am to 8pm***



- 1.) Each person applying for a campsite must hold a valid current Montgomery County Agricultural Society membership (\$30) or weekly pass (\$40)
- 2.) At least one adult (18 or older) must stay in each camper, RV or tent at night.
- 3.) Only one tent, camper or RV per site
- 4.) *Only one passenger vehicle per site* (hooked or unhooked)
- 5.) Fair camping will consist of a 9-day period beginning two days prior to the Fair and ending one day after the Fair closes. Additional camping before or after this period will require payment of a daily rate.
- 6.) Each camper, RV or tent must have a permit displayed in the window closest to entry door. Any passenger vehicle parking in the camping sites must have a parking permit displayed so it is visible in the front windshield.
- 7.) Subletting of sites is prohibited. The person purchasing the campsite shall be the one occupying that site. The Fair Board has the authority to remove the camping vehicle from the site and the vehicle parked in the spot for parking with the camper without further explanation. No refund will be issued.
- 8.) No animal feed or bedding may be stored on the campsite.
- 9.) NEW!! Tiki torches and Citronella candles are allowed in the campgrounds. You must have them extinguished by 12:00 PM (Midnight) nightly. Fire rings are available on a first come, first served basis.
- 10.) No ATV's, bicycles, four wheelers, or livestock are permitted in the campsite areas. Only Fair Board golf carts and/or authorized golf carts are allowed in the camping area. Permitted golf cart owners must have a \$100,000 liability insurance policy naming the MCAS as additionally insured, and a copy of the policy must be on file in the Fair Office. All golf cart operators must be at least 16 and have a valid driver's license.
- 11.) No unleashed pets are permitted in the campsite areas.
- 12.) All illegal activity is prohibited in the campsites.
- 13.) Campers shall keep their site free of trash and debris. Any person leaving trash in their campsite after the Fair will be asked to return and clean up their site or they will lose their site for subsequent years.
- 14.) All campers agree to conduct themselves in an acceptable manner and show consideration to all other campers, fairgoers, and fair management.
- 15.) The MCAS shall not be responsible for any loss or damage to either the camping vehicle, the vehicle pulling the camper, or the property of those camping.
- 16.) Failure to comply with these rules will result in forfeiture of all premiums, camping privileges, and removal of camper from fairgrounds with no refund.
- 17.) All general rules in the Fair book will be enforced in the camping area.
- 18.) The designated "Quiet Hours" are from 12:00 midnight to 6:30 AM daily. All campers are to be in their units during this time and no movement through the area will be permitted.
- 19.) The MCAS Board will rule on any question not specifically covered in these Rules.

To keep your campsite for the 2027 Fair, you must reserve and pay in full before the end of the 2026 Fair. Any campsite not reserved by 10:00 PM on Sunday, July 19th will become available for others to purchase. The updated campsite map will be available online starting Monday, July 20th at Noon.

GENERAL RULES AND REGULATIONS

“NO PERSON SHALL BE PERMITTED TO MAKE SOLICITATIONS OF ANY NATURE ON THE FAIRGROUNDS EXCEPT IN CONTRACTED CONCESSION OR COMMERCIAL RENTED SPACES. NO PERSON WILL BE PERMITTED. TO POST OR DISPLAY SIGNS, DISTRIBUTE HANDBILLS OR ADVERTISING MATERIAL OR SELL OR DISTRIBUTE FREE, ANY MERCHANDISE, EXCEPT PERSONS UNDER CONTRACT, AND WHO MUST OPERATE UNDER THE RULES AND REGULATIONS OF THE MONTGOMERY COUNTY AGRICULTURAL SOCIETY.”

2. The Montgomery County Agricultural Society will use every possible means to provide the safe preservation of articles, livestock and poultry entered for exhibition following their arrival and arrangement. However, Montgomery County Agricultural Society will not be responsible for damage to exhibits or livestock by fire, water, windstorm or any Act of God, nor does the Society assume any liability for loss by thefts or accidents to persons or property, nor for any errors or omissions in this Premium Book.
3. No alcoholic beverages are permitted in buildings or animal exhibit areas (including tents/structures).

NOTICE

ALL LIVESTOCK EXHIBITORS

(Large and Small Animals)

Please note that it is your responsibility to carry liability insurance on your animals exhibited at the Fair in the event that they were to bite, kick or in some way injure a patron of the Fair. Usually, it is a simple matter to have this added on to your homeowner's policy for the week of the Fair. If an accident does happen, contact one of the Senior Fair Board Director's and have them fill out an accident report immediately

SOLICITATIONS

“No Person shall be permitted to make solicitations of any nature on the Fairgrounds except in contracted concession or commercial rented spaces. No person shall be permitted to post or display signs, distribute handbills or advertising material or sell or distribute free, any merchandise, except persons under contract, and who must operate under the Rules and Regulations of the Montgomery County Agricultural Society.”

ENTRIES AND EXHIBITORS
Read the rules before making an entry
DO NOT ENTER IF YOU CANNOT STAY TO REQUIRED RELEASE TIME

1. Unclaimed exhibits from commercial and competitive Departments will be considered abandoned if not called for within thirty days after the official closing of the Fair, and may be disposed of as the Committee Chairman of the Department sees fit.
2. All entries for exhibition must be made in the name of the bona fide owner of the animal or article or the premium will not be paid.
3. Closing dates for entries will be found in the heading of each Department.
4. Entry blanks, properly ruled, will be found in the middle of this premium book if available prior to show (select shows entry forms are available day of show only).
5. Entries in the different department must be made on separate blanks. Only one exhibitor's entries to a blank form. All entries must be made on official entry blanks. Also, separate fees pad in each department. Extra blanks may be found at the fairgrounds office or on-line.
6. Anyone showing in open class must pay pen fees when applicable.
7. All exhibits must be on the grounds by opening day at 8 AM or as specified by the head of each department, with entry cards attached and will be under the control of the department members in charge of the proper department and must claim them, promptly, at the specified time at the close of the fair.
8. Exhibitors must deliver their animals or articles to the member in charge of the proper department and must claim them promptly, at the specified time at the close of the fair.
9. Exhibitors entering animals required to be pure-bred, must furnish Certificate of Registry in their respective herd, stud or flock books.
10. All animals shown as breeds must be such, in fact; if over three years old, must have produced living progeny, within the previous 18 months.
11. Animals entered in one class cannot compete for a premium in any other class except speed, sweepstakes, or as one of a pair or herd.
12. Incorrect entries are the responsibility of the exhibitor.
13. Exhibitors of cattle, swine, sheep and poultry: See Health Regulations on pages 35-36.
14. Exhibitors of livestock are required to keep their stalls open and in good order and their stock accessible to visitors, daily from 8:00 a.m. to 10:00 p.m. during the Fair.
15. Livestock exhibitors must be responsible for the removal of dead livestock during the Fair and thereafter, otherwise exhibitors will not receive premium money until the dead livestock is removed in accordance with the Chairman of the appropriate Department.
16. All animals entered in competition must be exhibited in the Show ring to be eligible for premiums.
17. To insure, as far as possible, the safety of all livestock and articles exhibited in other Departments, no stoves, fires or cooking of any kind will be permitted outside of the campgrounds. Where possible all lights must be out by 12:00 p.m.
18. No Chutes in the Barns until 10:00 pm, Sunday night.
19. No driving stakes in the blacktop in any of the livestock barns.
20. Only limited hay and feed to be brought into the barns.
21. Senior Fair Board committee members shall serve as Superintendents of Departments and are authorized to decide all questions arising in their respective Departments not covered by these Rules and Regulations
22. In cases where General Rules and Regulations conflict with Rules and Regulations governing Departments under which animals and articles are shown, Department rules will take precedence relative to the exhibit. Any point covered in the General Rules and not covered In Department rules, or vice versa, shall be considered as appearing in both.
23. Judges shall be procured for the judging of exhibits in each Department. Judges and members in charge shall see that proper tags are attached to all articles and animals entered for exhibition. Premium tags must not be attached to article or animals for which no premiums have been offered. Blue denotes first premium; red, second premium; yellow, third premium; white, fourth premium; green, fifth premium; royal purple, sweepstakes.

24. No premium will be awarded, with or without competition in any department, unless the judge considers the exhibit worthy of an award.
25. Judges shall not award any discretionary premiums. When articles of superior merit are exhibited for which no premiums are offered, the members in charge shall make note of the fact in the class book and the Secretary/Treasurer will report same to the Montgomery County Agricultural Society. Members in charge shall be permitted to use their discretion in recommending an award and shall note the fact in the class book. The Secretary/Treasurer will report this action to the Board.
26. If any disrespect is shown to an award or to the awarding judge by an exhibitor or their agents, the exhibitor shall forfeit all awards made to them and the member in charge shall report same to the Secretary/Treasurer upon return of the class book.
27. Protests relative to premiums may be made in writing to the Secretary/Treasurer before the close of the Fair. Decisions by the Judges will be considered final.
28. Premium checks will be voided 60 days after check date. Checks will not be re-issued. No exceptions.
29. Exhibitors, visitors or others are not permitted to tack signs to buildings, fences, or trees. It shall be the duty of the police to take into custody anyone so offending.
30. All protest from the current Fair have to be filed with the Fair office within 48 hours from the conclusion of the Fair.

NOTE: Exhibitors will furnish their own bedding.

901:1-18-01 CHAPTER'S APPLICATION.

- A) Animals when moved within or imported into Ohio solely for exhibition purposes shall comply with the requirements of this chapter.
- B) Animals described in paragraph (A) of this rule who are in compliance with the rules of this chapter are exempt from the other rules governing movement within or importation into Ohio except for the rules governing movement and importation of quarantined animals.
- C) Animals moved within or imported into Ohio for any purpose in addition to exhibition shall meet all movement and import requirements of Chapter 901:1-17 of the Administrative Code.

901:1-18-02 DEFINITIONS

As used in this chapter:

- A) "Approved veterinarian" means any licensed and accredited veterinarian approved by the Ohio department of agriculture, or an employee of the Ohio department of agriculture or the United States department of agriculture, animal plant health inspection service, veterinary services.
- B) "Certificate of veterinary inspection" means a form from the state of origin which has been issued and completed by a licensed and accredited veterinarian attesting to the health status and identification of an animal listed thereon.
- C) "Contagious or infectious disease" means any disease, including any foreign animal disease, or vector, capable of transmission by any means from a carrier animal to a human or to another animal and includes dangerously contagious or infectious diseases.
- D) "Department" means the Ohio Department of Agriculture or its designee.
- E) "Exhibition" means any public show of animals which is sponsored by or under the control of an Ohio county or independent agricultural society organized under Chapter 1711. of the Revised Code; or the Ohio State Fair; or which is assembled for a period which exceeds thirty-six hours or contains animals of origins other than Ohio.
- F) "Licensed and accredited veterinarian" means a person who is licensed by the State of Ohio to practice veterinary medicine and who is approved by the United States Department of Agriculture, animal plant health inspection service, veterinary services, to be an accredited veterinarian. 68
- G) "Residue" means any poisonous or deleterious pesticide governed by 40 C.F.R. 180 (2017), any poisonous or deleterious substance governed by 21 C.F.R. 109.6 (2017), or any other substance governed by 21 C.F.R. 556 (2017).

901:1-18-03 EXHIBITIONS: SANITATION, INSPECTION AND RECORDS

- A) Each entity sponsoring an exhibition shall have in attendance an approved veterinarian for the duration of the exhibition.
- B) Each entity sponsoring an exhibition shall:
 - 1) Under the direction of the approved veterinarian, thoroughly clean and disinfect each building, pen, stall, ring, or other enclosure in which animals are to be quartered for exhibition immediately prior to the exhibition;
 - 2) Have the approved veterinarian:
 - (a) Examine the certificate of veterinary inspection when required for an animal brought to the exhibition;
 - (b) Inspect within a reasonable time of arrival each animal brought to the exhibit for symptoms of any infectious or contagious diseases; and
 - (c) Inspect each animal daily that is present at the exhibition for symptoms of infectious or contagious disease.
 - 3) Maintain a record for one year from the date of the exhibition of each animal present at the exhibition. The record shall contain the name and address of the owner of each animal and the species and breed of the animal.
 - 4) Order the immediate removal of any animal which, in the opinion of the approved veterinarian, places other animals at unacceptable risk of disease.
- C) The department may grant an exemption from paragraph (B)(1) of this rule upon request and for good reason.

901:1-18-04 EXHIBITORS

- A) No person shall present for exhibition or exhibit an animal which he knows or has reason to suspect is infected with or has been exposed to a contagious or infectious disease or residue.
- B) The owner or bailee of an animal with symptoms of an infectious or contagious disease shall immediately remove the animal from the exhibition premises when directed by an exhibition official, the approved veterinarian, or the department.
- C) Each person who presents an animal for exhibition or exhibits an animal shall present any certificate of veterinary inspection, registration certificates, vaccination certificate, and other documents to exhibition officials, the approved veterinarian, or the department upon request.
- D) Each person who presents an animal for exhibition or exhibits an animal for which a certificate of veterinary inspection is required by the rules of this Chapter shall forward a copy of the certificate of veterinary inspection to the department.

901:1-18-05 POULTRY AND FOWL

A) All turkeys, chickens and gamebirds moved within or imported into Ohio for exhibition must either:

- 1) Originate directly from a flock or hatchery which is a participant in the national poultry improvement plan for the eradication of disease and be accompanied by documentary evidence that they meet the requirement of this paragraph;
- 2) Originate directly from a flock which has had a negative test for pullorum/fowl typhoid disease within twelve months preceding the opening date of exhibition and be accompanied by documentary evidence that they meet the requirement of this paragraph;
- 3) Have had a negative test for pullorum/fowl typhoid disease, within ninety days, preceding the opening date of the exhibition and be accompanied by documentary evidence that they meet the requirement of this paragraph; or
- 4) Be tested for pullorum/fowl typhoid disease upon arrival at the exhibition by a tester approved by the Ohio Department of Agriculture and found negative.

B) The rapid whole blood test shall not be used to test turkeys for compliance with the requirements of paragraphs (A)(2), (A)(3) and (A)(4) of this rule.

C) Waterfowl, doves and, pigeons are exempt from this rule.

901:1-18-06 CATTLE

A) Cattle moved within Ohio for exhibition must show no symptoms or evidence of an infectious or contagious disease.

B) All cattle imported into Ohio for exhibition must comply with rule 901:1-17-03 of the Administrative Code.

901:1-18-07 GOATS

A) Goats moved within Ohio for exhibition:

- 1) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
- 2) All sexually intact animals and any wether eighteen months of age and older must be identified with an official identification as defined in rule 901:1-13-04 of the Administrative Code.

B) Goats imported into Ohio for exhibition must comply with rule 901:1-17-06 of the Administrative Code.

901:1-18-08 HORSES, MULES AND PONIES

A) Horses, mules, asses, and ponies moved within Ohio for exhibition must show no symptoms or evidence of an infectious or contagious disease. If the animal is twelve months of age or older, the exhibition may require that the animal has been tested and classed negative to an official test for equine infectious anemia within twelve months of the opening date of the exhibition.

B) Horses, mules, asses, and ponies imported into Ohio for exhibition shall comply with rule 901:1- 17-07 of the Administrative Code.

901:1-18-09 SHEEP

A) Sheep moved within Ohio for exhibition: 71

- 1) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
- 2) All sexually intact animals and any wether eighteen months of age and older must be identified with an official identification as defined in rule 901:1-13-04 of the Administrative Code.

B) Sheep imported into Ohio for exhibition must comply with rule 901:1-17-08 of the Administrative Code.

901:1-18-10 SWINE

A) Swine moved within Ohio for exhibition must show no symptoms or evidence of an infectious or contagious disease.

B) Swine imported into Ohio for exhibition shall comply with rule 901:1-17-09 of the Administrative Code.

901:1-18-11 CAMELIDS

A) Camelids including, but not limited to, llamas, alpacas and vicuñas moved within Ohio for exhibition purposes must show no symptoms or evidence of an infectious or contagious disease.

B) Camelids including, but not limited to, llamas, alpacas and vicuñas imported into Ohio for exhibition must comply with rule 901:1-17- 15 of the Administrative Code.

MONTGOMERY COUNTY JUNIOR FAIR

General Rules

Eligibility

- Open to Montgomery County 4-H, Farm Bureau Youth, Girl Scouts, Boy Scouts, and FFA members. Ohio 4-H membership is based on a child's age AND grade as of January 1 of the current calendar year. Eligibility for Cloverbud participation begins when a child is age 5 and enrolled in kindergarten. Eligibility for participation in 4-H projects and competitive events begins when a child is age 8 and in third grade. Any youth age 9 or above is eligible for project membership, regardless of grade level. Membership requires enrollment in an authorized Ohio 4-H club or group under the direction of an OSU Extension professional or an approved adult volunteer. A youth's 4-H eligibility ends December 31 the year the youth turns 19.
- Market livestock exhibitors must reside in or attend school in Montgomery County. CTC students whose legal district is outside the county cannot exhibit CTC projects at the Montgomery County Fair. Cross-county petitions considered individually.
- All Junior Fair animal entries must be submitted through 4-H Online by the posted deadline.

Projects

- Exhibits must represent work completed within the past year as part of the member's organization. Projects/posters must be built in the same year the member is enrolled in that project and may not be reused, except insects and non-market animals. Violations make the project incomplete and ineligible for placing or premiums.
- A project cannot be entered in more than one organization (e.g. cannot show the same project in both 4-H and FFA).
- Members must attend 75% of club meetings to be judged. Clubs may count field trips, workshops, workdays, or fundraisers as meetings. Excused-absence policies must be in the club constitution and/or bylaws. Discuss special cases with 4-H staff. The club will meet a minimum of six times per year.
- College-age members meeting Junior Fair age rules and attendance requirements may have animals shown by another Montgomery County Junior Fair exhibitor.

Judging & Premiums

- Pre-Fair 4-H grades: A, B, C
- Premiums awarded for up to three junior fair projects/animals per exhibitor. Projects must be judged at County 4-H Judging or Fair Shows.
- Cloverbuds earn \$5 premiums if displayed in the 4-H booth.
- Premiums must be picked up at the Event Center Fair Office, 10am-8pm, July 14-19.
- Only Junior Fair entrants receive a wristband and premiums. If fewer than three exhibitors or five exhibits are in a class, awards/trophies are at the discretion of the judge and show committee.

Fair Conduct

- Exhibitors may not stay overnight on the fairgrounds unless with a parent/legal guardian in the campground, no barn/tent overnight stays.
- Exhibitors must follow the Junior Fair dress code.
- Participation is an opportunity to learn, meet others, and educate the public about agriculture in Montgomery County.

Safety & Restrictions

- The Montgomery County Agricultural Society, OSU Extension, FFA Staff, and volunteers are not responsible for loss or injury despite precautions.
- Family, friends, and guardians may not enter the show ring unless the exhibitor has an approved Winning 4-H Plan or special permission from that show's superintendent.

Only six (6) livestock projects can be entered per exhibitor in Junior Fair, this is a combination of 4-H and FFA projects.

Arrival & Health Requirements

1. Only animals entered in a graded class may be brought to the fair.
2. All Livestock are subject to Ohio Department of Agriculture health regulations and Revised Livestock Exhibition Rules.
3. All animals must be inspected by the Fair Veterinarian before stalling/penning.
Arrival window: Sunday 8am-8pm before the fair.
-Exceptions:
*Market Rabbits, Market Turkeys, Market Chickens: Sunday, July 12th, noon-6:30pm
4. Livestock must remain on the grounds until Friday, July 17th unless schedule or Senior Fair Board Directors approve otherwise, early removal forfeits awards and premiums.

Barn & Equipment Rules

5. No storage/chairs allowed in aisles or along barn walls, stalls/pens/coops must be cleaned upon animals removal. Storage above pens allowed (6'x6')
6. Exhibitors are responsible for meeting all show and weigh-in times, schedules may change.
7. Barns, aisles, stalls, feed, bedding, and supplies must remain neat and orderly. Aisles not being cleaned could result in:
-First violation: written warning (signed by member and advisor)
-Second violation: Animal removed, all placings and premiums forfeited.

Showing Requirements

8. Animals must be shown by the exhibitor unless they have two animals in the same class, the second animal may be shown by any active Montgomery County Jr. Fair exhibitor. Conflicts can be reported to the Superintendent/Jr. Fair Coordinator.
9. Exhibited animals must be a part of the member's projects and cared for by the member after possession dates. Any sale/consignment after possession date voids ownership, even if bought back.
10. Market animal registration limits:
 - 3 market lambs
 - 4 meat goats
 - 6 hogs (any combination of market/purebred)
 - 2 beef feeders
 - 3 steers/market heifers
 - 2 dairy feeders

One additional family animal may be registered if siblings have not reached their maximum. Eligible siblings must have registered at least one animal of that species, and a sibling's name must appear on the fair entry.

11. Animals cannot be replaced after possession deadlines. Sale animals must be selected before weigh-ins. Exhibitors must declare non-sale animals at weigh-in.
12. Only market animals may be sold in the Junior Fair Livestock Sale. Sale order is random except Champions and Reserves, which sell in the Sale of Champions.
13. A 4% sales fee applies, mandatory species check-offs also apply.
14. Sale checks are picked up at the Calumet Center on scheduled dates after buyers pay and Thank You notes are submitted.
15. No professional grooming. Assistance permitted only from Montgomery County 4-H advisors, immediate family or 4-H members. "Immediate family" includes all listed: parents, step parents, guardian, sibling, stepsibling, half-sibling relations and grandparents.
16. All animals, including feeder calves must be dehorned, exceptions apply to approved breeding goat breeds.
17. All animals must be broke to lead. Unruly animals will be dismissed, final decision by superintendents.
18. Animals must show to sell.

Health, Medication & Veterinary Oversight

19. Species committees and the Fair Veterinarian will inspect animals for injury/sickness, the Veterinarian may dismiss any animal. Members must remove animals immediately if required.
20. Ohio Livestock Quality Assurance Training is an annual requirement for youth exhibitors taking market animal or lactating animal projects. Junior fair exhibitors with market animals, market poultry, market rabbits, feeder calves, and lactating cows and goats must participate in the training or test out. Ohio Livestock Quality Assurance Training must be completed at least 45 days prior to fair arrival. Youth must check and follow the current year deadline.
21. All injections/medications must be administered by the Fair Veterinarian.
22. Members must accompany their animals to weigh-in unless arrangements are made with Superintendents.
23. All meat animals, meat poultry/rabbits, feeder calves, milking cows, and milking goats must submit an online DUNF at weigh-in. Animals must be past withdrawal times unless the Fair Veterinarian grants an exception.
24. The Montgomery County Agricultural Society and The Ohio Department of Agriculture shall have the right to test any animal prescribed by the Society to determine if a substance has been administered to change the conformation of temperament of the animal.

Disqualification & Ethical Conduct

25. Leaving competition without permission after entering the show area results in disqualification, forfeited premiums/awards, no sale, and a 3-year ban for the exhibitor and immediate family from the county competition unless deemed an emergency by that species department and the Jr. Fair Coordinator.
26. Fraud - including misrepresentation of breeding, age, ownership or fitting, results in withheld award/sale money and possible disqualification of animals and assistants.
27. If fraud is discovered before the sale, the animal cannot sell. Animals below move up in placing. If violations are discovered after the sale, all sale money returns to the buyer, carcass/value returns to exhibitor, placings stay the same, suspicious carcasses may be held.
28. Unethical fitting includes cutting/tearing hide, altering tissue, disrupting dental development, coloring hair, adding artificial parts, or altering firmness via fluids/air.
 - Only transparent grooming materials allowed: water only for hogs.
 - Unapproved drugs prohibited
 - Violations cause loss of all premiums/awards and a ban from exhibiting, violations are reported to ODA.
29. If a carcass is condemned for any reason, the exhibitor forfeits premiums and sale money and bears the loss, disqualified from on-foot and carcass division.

Champion Animal Handling

30. The Agricultural Society may hold Grand/Reserve Champions or any tested entry in a secured building until ODA release. Exhibitors must provide feed, water, and assistance with transport, Society representative and family must accompany the animal to the processor.

Governance & Sale Contingencies

31. The Junior Fair Livestock Committee recommends all livestock rules to the Senior Fair Board Livestock Committee. Suggestions may be submitted. Voting privileges exist for eligible parents, guardians, volunteers, board members, and superintendents who have attended two of the last three meetings.
32. If no acceptable packer buyer is secured for a species, exhibitors must market their own animals and may receive only the premium but minus the year's sale commission.

Junior Fair Rule Violations

In the question of a rule violation the following due process will be used: exhibitors and/or parties involved will be questioned by Fair officials. If it is felt a violation has occurred, Fair officials will make recommendations to the designated committee of the Agricultural Society which is appointed to the department in question. After the committee hears allegations and/or evidence, they will decide if the case should be brought before the full Senior Fair Board. In the decision of allegations being brought before the Board, all parties involved will be notified of a meeting date with all parties having the right to present their views and/or evidence. Upon hearing the case, the Fair Board will make a ruling. When satisfactory evidence has been obtained by the Montgomery County Fair Management that any of the livestock rules have been violated, the exhibitor and/or exhibitors' family may be barred from showing in any future Montgomery County Agricultural Fairs. The minimum number of years for being barred is three (3) years before the right to review. In case any premium shall have been awarded to the animals shown in violation of this rule the Montgomery County Fair Management will request the exhibitor to refund all premiums, trophies, awards, ribbons, and sale money under such violation. Unless fraud and/or deception are involved, all championship placing stand.

Protests & Appeals

Protests must be submitted in writing, by the party or parties making protest, and filed with the Executive Secretary and the Junior species Superintendent within 4 hours of the conclusion of the Fair. Upon receipt, the Executive Secretary and Junior Fair Species Superintendent will provide their recommendations to the Junior Fair Livestock Committee within 24 hours. A protest fee of \$250 is required. (Payable by cash, check, or money order). The Montgomery County Agricultural Society will retain the fee if the protest is not upheld. All protests will be considered during a meeting scheduled by the Senior Fair Livestock Chairman of the Montgomery County Agricultural Society, and all involved parties will be notified. The Senior Fair Livestock Committee along with any other necessary parties, will review and address the protests.

Dress Code– Montgomery County 4-H/FFA Livestock Shows

1. Exhibitors must wear appropriately fitted long or short sleeved collared shirts (one collar button may be undone). 4-H club crew neck t-shirts are allowed. Shirts must full cover the midriff and bosom at all times. Clothing may display only 4-H FFA, or Farm Bureau logos, no other lettering or logos.
 - Long, full– length pants of proper fit are required, no capris or shorts
 - Closed-toe, protective shoes/boots required, no sandals
 - No hats while exhibiting, except in horse shows
 - Conservative, coordinated colors preferred, exhibitors must appear neat and clean.
2. Poultry and Rabbit exhibitors can wear short-sleeved shirts or show jackers within Rule 1 standards. APA, ARBA, area, and breed patches are permitted.
3. Dairy exhibitors must wear white shirts and white pants within Rule 1 standards.
 - Dairy goats: show whites preferred but not required
 - Boer goats: Fair attire
4. Any dress code violations results in exhibitor being barred from showing, and premiums and the right to sell the animal are forfeited.

General Showmanship Contest Rules

1. Exhibitors must show an animal they own and are exhibiting as a current 4-H or FFA project animal.
2. Divisions are by age as of January 1:
 - Junior: 8-10
 - Intermediate: 11-13
 - Senior: 14-18
3. Divisions may be combined or split based on entry numbers. If only two cases are held:
 - Junior: 8-13
 - Senior: 14-18
4. Judges evaluate:
 - a. Animal appearance, cleanliness, fitting and behavior
 - b. Exhibitor appearance , including proper attire without commercial advertising.
 - c. Exhibitor ability to handle/ maneuver the animal as directed.
 - d. Exhibitor knowledge of the animal, techniques and procedures.
5. Winners of each age division compete for department showman, species winners advance to large or small animal Overall Showman of Showmen.
6. Exhibitors who cannot participate in Showmanship must complete the species Skill-a-thon. Failure to complete one of these two options results in not showing or selling in the sale.
7. Previous Overall Showman of Showmen winners may not enter the Overall Contest again during their show years and are exempt from the interview. They may still compete in showmanship in other species.
8. If a past Overall Winner wins their species' Showman Contest again, they reserve species winner advances to the Overall Contest.
9. Species awards remain with the original winners.

Rabbit & Poultry Showmanship

1. Participants must use one of their own project animals shown in Jr. Fair for showmanship.
2. Dress Code: See General Showmanship Rules above.
3. Judges consider these points:
 - The general appearance of the animal cleanliness, how fitted, behavior, etc.
 - The general appearance and handling by the exhibitor.
 - The ability of the competitor to maneuver the animals as directed by the judge
 - The knowledge of show techniques and procedures as demonstrated by the exhibitor
4. Rabbit Showmanship Age Divisions are Junior, Intermediate, and Senior. Divisions will be posted prior to the show.
5. Poultry Showmanship Age Divisions are Junior, Intermediate and Senior. Divisions will be posted prior to the show.

Large Animal Showman of Showmen Contest Rules

Large Animal Award Donor: Jackson Hile

1. Winners of Showmanship in Beef, Swine, Horses, Meat Goats, and Dairy Goats compete in the Large Animal Showman of Showmen Contest. One Reserve per species is selected. All winners must attend a mandatory rules meeting at 9:00 pm on Thursday and must confirm participation within 2 hours of their species contest.
2. Species Showmanship winners receive a bye for that species. If a member wins multiple species, they choose which species to represent, the reserve fills the other species.
3. Contestants show animals in all species except for the species in which they have won. Participants must demonstrate skills in their familiar species after judging. Judges may switch animals among contestants and ask questions, animal switching is strongly encouraged.
4. Department Superintendents, with the contest committee, select animals of equal show-ability for use. Contestants draw lots for animals. If equal-quality animals are limits (e.g., horses), superintendents and the committee will adjust as needed.
5. Champion Showman of Showmen is chosen based on livestock knowledge, handling ability, courtesy in the ring, and proper show ring practices.
6. Dress Code follows the general show dress code policy.
7. Each judge receives 15 minutes to judge their species. Scoring staff will monitor time and give a five-minute warning. Horses may vary but judges must move efficiently.
8. Show order for large animal showman: Horses, Swine, Beef, Sheep, Market Goat, Dairy Goat.
9. Placings 1-6 receive points: 1 point for 1st, 2 points for 2nd, etc. Lowest total score win. No contest results are announced until the end. Score sheets are available upon request to contestants only.
10. Ties are broken by the greatest number of 1st-place class finishes, then 2nd-place finishes, and so on until resolved.

Small Animal Showman of Showmen

Show order for small animal showman: Will be in rotating stations

1. Overall Small Animal Showman of Showmen will be determined in a Showman of Showmen Contest with the first place winners in each division of Rabbit and Poultry Showmanship classes.
2. Divisions are Showman of Showman of: Meat Rabbits, Meat Chickens, Market Turkeys, Breeding Rabbits, and Breeding Poultry.
3. Each Exhibitor will show an entry selected by Jr. Fair Superintendents for each division participating.
4. All rules under "Large Animal Showman of Showmen Contest Rules" (excluding eligibility; see Rule #5) are followed.
5. The Species Showman of Showmen is not eligible to participate in their respective species Showman of Showmen Contest until they are eligible by age for the next age division for that species. However, they can participate in another species Showmanship and enter the Contest through another species.

Example: an Intermediate division winner at age 12, wins Small Animal Showman of Showmen through Market Chickens. They cannot compete in Market Chicken Showmanship until they are age 15 - Senior division. However, they can compete in all other Small Animal Showmanship and enter the Contest through another species.

Junior Fair Premier Exhibitors & Skill-a-Thons

Premier Exhibitor Program

One exhibitor in each Junior fair species (beef, dairy, goat, sheep, swine, rabbits, poultry and horses) will be recognized as the Premier Exhibitor for that species. This honor and monetary award is based on points earned from:

- Skill-a-thon contest
- Ohio 4-H livestock Record Book scoring
- Showmanship
- Show placing
- Sportsmanship & etiquette in and out of the ring.

This format follows the Ohio State Fair Outstanding Market Exhibitor program. Poor sportsmanship, poor animal husbandry, or undesirable behavior may affect placing. Exhibitors must have a completed Ohio 4-H Livestock Record Book for that species to be eligible.

Skill-a-Thon Contests

- Date/Time: June 30th from 9:00am - 12:00pm and 3:00pm - 6:00pm
- Registrations: Closes at 6:00pm, anyone in line by 6:00pm for a species station will be allowed to participate.
- Each species skill-a-thon consists of a test on an iPad. It is out of 40 points. There will be a QA test component and a tie breaker. Youth should bring their current year Ohio 4-H livestock record book or FFA project book to be scored
- Study materials include: 4-H record books, 4-H resource books, Quality Assurance information. You can also review the species specific information located at <https://ohio4h.org/animalsciences>
- Members may participate in any species' skill-a-thon, even without being enrolled in that project.
- Cloverbuds are not allowed to participate in the skill-a-thon.
- Skill-s-thons are broken down by age divisions based on 4-H age as of January 1 of current year.

Junior Fair King, Queen & Ambassador Contest

Eligibility Requirements:

1. Contest will be held in May before the fair. 2026 is the only exception where a Junior Fair Queen/King Contest will not be held.
2. Contestants must be 15 years of age or older as of January 1 of the current year.
3. Must have at least 1 year of club work completed (not counting the current year).
 - Previous county Junior Fair Kings and Queens are ineligible.
 - Court members and finalists may re-apply.
4. Each entrant must submit an application.
 - Details on application deadlines will be in the 4-H Newsletter, "Clover Connections".
5. No limit on entries per club. Entrants must be current members of a 4-H Club, FFA Chapter, or Girl Scout Troop with displays or animal entries at the current Montgomery County Fair.
6. Business attire is expected for interviews and on stage speeches during our 2026 season for our ambassador contest.
7. Scoring breakdown:
 - Activities (Participation, Leadership, Achievements, Initiative) – **45%**
 - Poise & Personality – **25%**
 - Individual & Public Interviews – **30%**
8. Interviews will be held at the Calumet Building and the evening Sashing will be held in the Gym.

Responsibilities During the 2026 Reign

1. King, Queen, and Court participate in the Fair opening day parade and ribbon-cutting ceremony.
2. Royalty & Ambassadors attend as many Junior Fair events as possible and assist with ribbon and trophy presentations.
 - Daily expectation to greet the public and walk among attendees.
3. The Royalty & Ambassadors must dress appropriately to represent county youth.
 - Sashes should be worn whenever possible.
 - Proper manners and behavior are expected.
4. The court will fill in as needed for the King/Queen & be included whenever possible.
5. The reigning King & Queen will attend next year's contest and host the program.
6. The Queen will participate in the Ohio County and Independent Fair Queen Contest at the Ohio Fair Managers Conference in the following January.
 - Required information and forms are due **October** of the current year.

Exhibitors and Families Please Read

- There will be no multi-buyer card this year. Live lots will be bought by 1 buyer in the live sale.
- The live auction will limit the number of buyers of an animal to no more than 2. The cost will be divided evenly between the 2 buyers.
- Each market exhibitor will be able to go through the sale ring one time per species they exhibit. The exception to this would be if they exhibit an Overall Grand or Reserve Champion Market Animal. If that exhibitor has more than one animal of that species, they will be able to be in both the Sale of Champions and the live auction.
- Each lot sold through the sale will be subject to a 4% commission.
- Participation in the live sale will cost \$20 per time the exhibitor enters the sale ring. This cost will be paid by the Junior Livestock Committee.
- Breeding livestock exhibitors (including dairy exhibitors) will be able to have a lot online for add-on money. These exhibitors will be subject to 4% commission. There is a \$14 fee to participate only in the online portion of the sale. That fee will be paid by the Junior Livestock Committee.
- The online add-on portion of the sale will open at 3 PM on Friday after the live auctions.
- Exhibitors participating in the online add-on sale will have one total lot for all of their livestock and breeding projects.
- Buyers who participate in the live auction and the online add-on sale will receive 2 invoices, 1 for each sale.
- Sales are an optional part of any livestock project. Per Ohio 4-H, participation in a sale is not necessary for a project to be considered completed. A project is considered completed when the animal is exhibited.
- The Sale of Champions will be directed by the Sale of Champions Committee.
- The Sale of Champions will allow for a group of buyers to form a group larger than 2 for the purchase of those animals. The group will need to have 1 buyer responsible for bidding and collection of all monies. All buyers in that group will be recognized at the auction at the time they place their winning bid.
- All Champion Animals will go to slaughter and will not be available for processing.

Montgomery County Born and Bred Class: To be eligible for this market or breeding class the 4-H or FFA member must own and be in possession of the project mother prior to time of conception or have purchased their calf, steer or female from a Montgomery County breeder who has bred and born that calf. Members must notify beef superintendent by May 1st to allow for on the farm inspection and to check the qualifications of the animal at time of registration. All other beef breeding animals must be in the possession of members by May 1st.

Beef Breeding Classes: Registration papers of animals in beef breeding classes need to be shown to Beef Superintendent on Sunday during steer weigh-in. Animals to be shown by breeds in the following classes: Limit 2 entries per class; no bulls.

(A) Angus (B) Hereford (C) Simmental (D) Shorthorn (E) Any Other Breeds (AOB) and Crossbred

Beef & Dairy Feeder Calves

1. Born after December 1st, 2025. Must be weaned and in member possession by May 1st. Heifers can be taken as beef dairy feeders - and will remain in market classes and cannot be shown in breeding classes.
2. All castrated animals must be fully healed at weigh ins. Males must be castrated by May 1st.
2. No more than 4 entries per exhibitor. - 2 beef and 2 dairy.
3. Pre-registration photos and info are due online by 1st Sunday in May
4. Calves must be de-horned and healed before coming to the fair. Males not fully castrated and healed, will not show and will not sell.
5. Feeder calf exhibitors may show and sell 2 beef and 2 dairy calves through the livestock sale. Calves must weigh between 300 and 900 pounds to be sold in the sale.
6. At the weigh-in scale, members declare if animal is to be sold or taken home at that time. Online DUNF forms must be completed.
7. Market Heifer Feeder Calves may continue as Market Heifers or Breed Heifers the following year.
8. All classes will be shown by weight as determined at Weigh-In. EID Tag must be in place on farm and match registration.

Steers and Market Heifers:

1. All Steers and Market Heifers must be on feed, in exhibitor's possession by December 1st, 2025. All Market Beef/Dairy must be born after December 1st, 2024 and must be registered by designated date in December.
2. Youth may register no more than three (3) steers/market heifers, then show and sell three (3) steers/market heifers at the Fair. Steers/market heifers must weigh at least 900 pounds at weigh-in to sell in the sale.
3. Any Steer that arrives at the Fair not fully castrated will not show and will not go through the livestock sale. Fair Veterinarian and superintendents will have final ruling. All market beef must be de-horned and healed.
4. At the weigh-in scales, members will declare if animal is to sell or be taken home. Online DUNF form must be completed. Calves weighing less than 900 pounds will be shown in an underweight class and be ineligible for championship classes. EID tags must be in and verified.
5. Champion Born and Bred will not show in the final drive.
6. In the interest of safety, any steer/mkt heifer that cannot be led at any time during the Fair may be sent home. Decisions to be made by Beef Superintendents and a member of the Extension Staff.
7. 2026 Junior Fair Steer Registrations will be due December 15th, 2025. For details, contact the Extension Office or Superintendents. Market animals must be in possession of youth exhibitors by December 1st

2. Market lambs must be castrated by May tagging date. Any market lamb that arrives at the Fair not fully castrated will not show and will not sell. Fair Veterinarian and superintendents will have final authority.
3. Lambs must be shorn by weigh-in and slick-shorn to show in market classes.
4. The altering of the natural color of a lamb above the legs shall be considered fraud and deception.
5. All market lambs must weigh at least 95 pounds to be eligible to sell in the Junior Fair Livestock Sale. Suggested weights are 100-150 lbs.
6. Junior Fair Market Lambs will be registered online the 1st Saturday in May. All lambs must have scrapies tag for pre-registration photos and info.
7. No muzzles will be used.
8. Market animals must be born on or after Dec. 1st, 2025.
9. Members must have animals in possession by May 1st.
10. Market classes to be determined after weigh-in, shown by weight.
11. No cooling towels.

Commercial Ewe Breeding Class

All Commercial Ewe will weigh in. Ewes raised for market lambs cannot be shown as commercial ewes. Commercial ewes will not compete for champion market animal.

Exhibitors must declare at scale if animal is going on market trailer or home. The Supreme and Reserve Supreme must sell. Each exhibitor can enter the sale ring with one hog representing your total 4-H/FFA market hog project for the premium bid. Supreme and Reserve winners can enter 2nd time

Showmanship Classes will be as follows:

Show order will be Senior, Intermediate, and Junior (11, 10, 9, 8). Senior and Intermediate division exhibitors will be randomly divided into even classes within their age division. Junior classes will consist of 8, 9, 10 and 11 year old classes. All class winners, along with second place in each class, will return for their respective Division Championship. Champion and Reserve Champion Swine Showman will be selected from Champion and Reserve Champion Division Winners

- Senior Division: 15-18 years old

- Intermediate Division: 12-14 years old

- Junior Division: 8-11 years old

Classes: 139 A Crossbred Market Barrows, 139 B Crossbred Market Gilts, 139 C Purebred Gilt/Barrow

- Crossbred entries will show by weight and gender. Classes will be broken based on the number of entries, with no more than 10 animals per class. The 1st place winner in each weight class will enter their respective gender Champion Drive, with 2nd place class winners on deck for the Reserve Champion Drive

- All purebred animals must be registered in the name of the exhibitor, farm name, or family name. Registration papers will be reviewed at the weigh-in scales. The purebred show will combine gilts and barrows in one class per breed, provided other requirements and show numbers are met. Purebred entries will show by breed and weight only. Weight classes will be no more than 10 animals.

- **NEW:** Montgomery County Born & Raised Purebred Show. County Born & Raised animals will be placed according to their placings in regular purebred class. At conclusion of Purebred Show, all first and second place County Born & Raised animals will return for Champion and Reserve Champion Montgomery County Born & Raised. Registration papers must include the breeders address, located within Montgomery County.

- The Supreme Champion Drive will consist of all Champions selected; with the exception for the Champion Montgomery County Born and Raised. There will be a total of 5 overall placings in this Drive. Supreme Grand Champion and Reserve Supreme Hogs must sell in the Jr. Fair Sale and be harvested.

1. Members must register and can any combination of up to 6 head of hogs (barrow, gilt, purebred, crossbred).
2. Members must have animals registered with photo of the EID tag number that is readable in the pigs ear, along with photos of left-side, right-side, and head of each hog by the first Saturday of May. No tagging of animals at weigh-in! All barrows must be castrated by the first Saturday in May. For 'family' animal – see Rule# 10 on page 85.
3. Hogs may be sold at 'market' price or be taken home. This decision to sell or take home is made at the weigh-in scale! Only hogs that weigh between 220-320 are eligible for market trailer.
4. Any market barrow that arrives at the Fair not fully castrated will not be shown and must go home immediately. Fair Veterinarian and superintendents will have final ruling authority.
5. Shavings are highly recommended for bedding hogs. Ground corn cobs may used for bedding, but kickboards open to the aisle ways must be used. No straw.
6. Pens should be cleaned daily and aisle ways swept often. Members with pens not cleaned after one warning will forfeit their Fair winnings.
7. Show boxes and similar storage containers will be stored over the top of 6 ft. x 6 ft. pens only. No storage, chairs, etc is permitted in the aisle ways or along the wall space.
8. The Showmanship entry must be one of the hogs shown in Junior Fair. Once the hog entry for showmanship is determined, that same animal will be used through all hog showmanship classes for the one designated exhibitor.
9. Hogs may only be shaved on tail and ears. All other clippings must have at least ½ inch of hair.
10. Water only may be used in grooming for the show.
11. There will be no minimum weight or maximum weight to show the animal.
12. Pigs being taken home and not going on market livestock trailer must be removed from the barn as soon as the Auction concludes. All tack must be removed 1 hour after the sale.
13. All rules are subject to the discretion of superintendents.

Exhibitors must clean stalls and pens when their animals are removed.

All market goats will be wethers or meat wether does. Meat wether does will show in separate classes from meat wethers and will have a Grand and Reserve awards but not required to sell.

Breeding Stock Leases: Must be turned in by 10am on first Monday in May at Extension Office or attached in 4-H Online Entry.

All goats register online either by a scrapies tag, registry ID, or implant from the point of origin according to Ohio Code State Specific Regulations Scrapie-- 901:1-13 Purpose: to enable trace back of animals that test positive for scrapie or another program disease to their flock or herd of origin and trace out of exposed animals from infected and source flocks. The Ohio State Veterinarian has final authority.

All wethers and meat wether does must have the USDA scrapies tag. The scrapies tag must be in the ear and visible in the online registration photos due the 1st Saturday of May. Animals arriving at the Fair with no scrapies tag will result in the animal being sent home. Superintendents and Senior Fair Board Directors have final say.

1. Stalling is two goats per pen.
2. No bucks are permitted on the Fairgrounds.
3. All animals must be owned by the member, member's parents, or in partnership with his/her parents by May 1.
4. Market goats must be identified and fully castrated by the county registration date or will not show and will not sell. Fair veterinarian and superintendents will have the final authority.
5. It is the responsibility of the club advisor and member to turn in entry forms according to county guidelines and verify that it is correct. **Error and missing exhibitor information will result in animals not being shown

Dairy Doe classes & Exotics are Junior Division (ages 8-13) and Senior Division (ages 14- 18). All ages are as of January 1, current year. Classes are divided by the Junior Fair Board and Superintendents with run-offs for each age division as needed.
2. Exhibitors must show project owned by exhibitor in showmanship class.
3. Show in appropriate class for your animal: meat goats, dairy meat, meat breeding are Meat Goat Showmanship; dairy does and exotic does are Dairy Goat Showmanship. Youth may enter both showmanship contests with appropriate projects. Each winner advances to the Showman of Showmen Contest on Thursday.
4. Show whites preferred for dairy breeds. Boer breeding and market goat exhibitors should follow Jr. Fair dress code requirements.
5. Exhibitor should do most if not all of the grooming of showmanship animal

Market Show - (Dairy Wether, Meat Market Wether, Slick Shorn Wether Dam)

Tuesday 6:30pm

1. All market dairy and meat animals must weigh at least 55 pounds and be under 1 year old at weigh-in, and have no milk teeth. Animals will be subject to mouth/teeth check by Fair vet or judge and may be disqualified. Underweight animals can be shown but will receive a B grade ribbon and are not eligible for any awards. Underweight animals will not go through the livestock sale and will not be sold with the goat projects to the markets (member will have to make their own arrangements to remove any under- weight animals at release time of the fair.)
2. The market goat may be a wether or meat wether doe. Meat breed goats listed in section below.
3. Market Wethers and Slick Shorn Wether Dams will show in separate classes by weight.
4. Slick Shorn Wether Dams will not compete for Over all Grand and Reserve Champion.
5. Dairy Market Class shall consist of Alpine, LaMancha, Nubian, Obershasli, Saanans, Toggenburg or a cross thereof.
6. Meat Class shall consist of any animal that has any percentage of a breed not mentioned in dairy breeds. The final decision of class determination will be made by the judge and superintendents at weigh-in.
7. Any animal producing a product going into the food chain can be subject to drug testing as requested by the judge and or show committee the day of show. It is the responsibility of the exhibitor to insure that all medications are used within label guidelines. Any animal tested is at the owners' expense.
8. Awards given for Grand and Reserve Champion Light weight, Middle weight and Heavy weight classes for both Dairy and Boer. Division breaks will be set by Superintendents once all animals are weighed in. These classes will compete for overall Grand and Reserve Champion of the Dairy and Boer.
9. The Grand and Reserve from both the Dairy Market and Meat Market wether show will be sold as the first four wethers sold in the goat sale, followed by all other goats by random draw
10. Grand Champion & Reserve Grand Champion Meat Market wether Goats WILL be tested per ODA rule

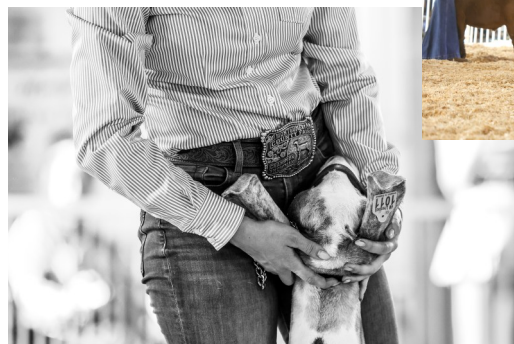

All Animals must be checked in and checked out by a Small Animal Superintendent.

All Market animals exhibits must complete an online DUNF form at weigh-in. All poultry, except waterfowl, show NPIP papers (hatchery papers), home hatched and raised turkeys show Blood Test Papers before weigh-in. Failure to produce these forms for each animal will prohibit the animals from being shown or sold at this Fair.

Release Times

- **All Market Rabbits and Market Poultry** not going to market must be out of the barn between 8:00pm and 10:00pm after the Friday sale. Any exhibitor who does not clean their pen will have \$25 deducted from their sale checks.
- **Breeding Rabbits & Breeding Poultry** are not released until Friday at 8:00pm and no later than 10:00pm. Exhibitors needing to remove their animals before the release time must have a parent and club advisor meet with the Small Animal Superintendents immediately following check-in on Thursday to fill out an early release form. Any exhibitor that removes their animal before the release time, without an early release form, will not be eligible to show small animals the following year; NO EXCEPTIONS.

Coop Cleaning

- All pens/coops are to be cleaned by 11:00am daily (**DO NOT CLEAN DURING SHOW TIMES.**) Cleaning must be done every day, using no more than 2 inches of bedding. Pens not cared for on a daily basis will be removed from the Fair and competitions at the discretion of the Superintendents, Extension Staff and Fair veterinarian.
- All Meat/Market pens must be cleaned on Wednesday; no exceptions. **Any exhibitor who does not clean their pen will have \$25.00 deducted from their sale check.**
- Breeding Rabbits & Breeding Poultry pens must be cleaned within 1 hour of release on Friday evening; no exceptions. Any exhibitor who does not clean their pen will not be eligible to show the following year and a \$25 fee will be charged.

Sale Notes

- All rabbits and poultry in the Jr. Fair Small Animal Sale will be sent to market. An exhibitor wanting to take their animal(s) home must declare this at the weigh-in scale.
- Buyers will only have the option to either take the animals home that night - live - or the buyer can send the animal to market. There is NO OPTION for a buyer to send animal(s) home with the child.

2. Only cages are provided by the Montgomery County Small Animal Department. All bedding, feed and other animal care equipment is the responsibility of the exhibitor.
3. Rabbits must be checked in and out by a small animals superintendent and will not be allowed to be on exhibit if in unhealthy condition.
4. All market rabbits will sell in Jr. Fair Sale. Market rabbits must be raised at youth exhibitor's home or farm (unless prohibited by city ordinance) by June 1.
5. Rabbit Meat Pen: If the tattoo/marker numbers at Fair check-in do not match the tattoo/marker number on the 4honline entry, animals will not be accepted for exhibit and must go home.
6. Rabbits must weigh between 3 to 6 pounds to qualify that pen for Grand or Reserve Grand Champion. Meat rabbits can be animals of same breed or can be mix of breeds. (Members can bring and weigh-in 4 meat rabbits; but can only show 3 per pen.)
7. All meat pens not taken home by sale buyer, will be sold at market price and picked up by our buyer. Time/date to be posted.

Poultry Rules

1. Animals must be owned and in possession of exhibitor by: Breeding Birds, Layers – May 1st.
2. Market Turkeys – Cages are provided by the Montgomery County Small Animal Department. All bedding, feed and other animal care equipment is the responsibility of the exhibitor.
3. All poultry must be checked in and out by a small animal superintendent and will be excused if in unhealthy condition.
4. Poultry meat chickens and market turkeys will sell in Jr. Fair Sale. Meat chickens and turkeys must be owned within 48 hours of hatch and raised by their exhibitor.
5. Meat Chickens Broilers - Cockerels only; each chicken must weigh 3.5 to 7 pounds. Pullets will be weighed in, but not eligible for Championships. Members can bring and weigh-in 4 birds, but can only show 3. All meat pens sell. However, only broiler pens will be considered for championship class.
 - Overweight birds will be moved to a Roaster class.
 - *Roasters are defined as any broiler over 7 pounds. If a meat pen has 1 over weight bird, the other birds will be moved to a single fryer class.
 - *Fryers are defined as any broiler between 3.5 to 7 pounds.
6. Market Turkeys: Only tom turkeys will be eligible for Championship class. No minimum or max weight. Hens will be weighed but not considered for Championship.

Age division will be based on age as of January 1, current year: Junior (age 13 & under) and Senior (age 14 & older). Age divisions may be adjusted by the committee after entries are finalized.

Rules:

1. Exhibits must be project animals cared for by the exhibitor who is a member of a Montgomery County 4-H Club or FFA Chapter.
2. Current 4-H and FFA Members: Only currently enrolled Montgomery County 4-H and FFA members may exhibit and show llamas/alpacas at the Montgomery County Junior Fair. 4-H members must be enrolled in a club with llama/ alpaca project(s) by April 1st of the current year using 4-H Online.
3. Skill-a-thon: 4-H llama/alpaca exhibitors must bring up-to-date project and record book to skill-a-thon. All 4-H llama/alpaca exhibitors are strongly encouraged to participate in the llama/alpaca skill-a-thon.
4. All project animals must be entered into 4-H online with photo by May 4th. Exhibitors may show one project animal per class, with a maximum of two animals entered by an exhibitor. If using two animals, both must be entered into 4H Online by deadline.
5. A llama/alpaca may be shared by two 4-H or FFA members of different age divisions.
6. All exhibitors are expected to be present and care for their own animal(s) while exhibiting at the fair until exhibits are released.
7. Each exhibitor is responsible for keeping pens, aisles, and tack clean and orderly during fair.
8. All stalls, aisles, and areas used by an exhibitor must be cleaned before the exhibitor leaves.
9. Animals must be at least 6 months old and weaned by the possession date (April 15).
10. Only project animals are permitted at the fair; companion animals are not permitted. Only exception is a nursing cria.
11. Exhibitors may not show intact males that are over 18 months old as of the first day of the fair.
12. Llamas/alpacas will compete on the same course with size adjustments at the judge's discretion.
13. An exhibitor may show only one animal per class.
14. No dogs allowed in the barn under any circumstances. Anyone bringing a dog into the barn will be asked to leave immediately. Service animals are welcome but asked to stay as far from the camelids as possible for the safety of exhibitors and dogs.
15. Exhibitors must wear the standard apparel while showing at the fair. This consists of long or short sleeve shirts with collars. Long pants; not shorts or capris. No open toed shoes or sandals.
16. The judge has the authority to dismiss dangerous and uncontrolled animals. If an animal is dismissed there will be no placing of the animal by the judge.
17. All llamas/alpacas are required to be shown in a well-fitted halter and lead

Llama/Alpaca Class Descriptions:

Llama/Alpaca Showmanship

1. Judged on how well the exhibitor reacts with the llama or alpaca and how well the llama or alpaca is trained as it is presented at its best advantage to the judge.
2. Exhibitor must demonstrate basic skills in presenting the animal to the judge, grooming and following directions.
3. The llama or alpaca's conformation is not considered.
4. The handler's attire should be neat, clean and appropriate for the class.
5. A good showman is polite and courteous to other exhibitors, displays good sportsmanship and pays attention to both the animal and to the judge at all times.

Llama/Alpaca Public Relations

1. The class is for the llama/alpaca that participates in community activities, goes to schools, hospitals, service clubs, parades, charity functions, or other events.
2. This competition also examines the animal's trust in its handler, while using its own intelligence to evaluate tackling each obstacle. Exhibitor and animal are judged on their ability to negotiate obstacles and perform activities in the community.
3. The course will include obstacles found in a community, including but not limited to: Stairs or ramps, petting by strangers, picking up foot/showing teeth, and loading into a trailer.

Llama/Alpaca Trail Pack/Obstacle

1. Exhibitors will be required to navigate their animals through four (4) to eight (8) obstacles depending upon the arena space available. Obstacles may include but not limited to jumps, maneuverability, a change of pace, backing, a bridge, ramp, standing water, moving objects, and items obstructing their pathway.
2. Exhibitors must provide a pack and fill material to bulk packs out. Packs must carry no weight. Llamas/alpacas must wear a pack proportionate in size to their body. A training pack may be used.

Llama/Alpaca Costume Class

1. The exhibitor decides on a theme and dresses him/herself and the Camelid to illustrate the chosen theme.
2. Costumes will be judged on theme, originality, creativeness, the coverage of sensitive areas of the animals such as its head, back, legs, ears, etc.

All 4-H and FFA horse members must compete EquiSTEP by 1st Sunday in May. Must attend Safety Clinic/Horse Quality Assurance (Parent/Guardian & Youth), 1 ride-in (youth with horse), and Horse Camp (youth with horse) to compete at County Fair.

Open Ride Times: No open riding or in-hand work without adult supervision. Boots and helmets required. Absolutely no bareback riding allowed! No riding in grass. Open riding and in-hand work to be done inside the arena.

1. All 4-H Horse events will be governed by Ohio 4-H and the Ohio 4-H Uniform Rules (4-H publication #179).
2. Must have animal(s) by 1st Sunday in May, current year. Youth may register up to 2 horses, and may bring and show 2 horses at the fair, must be in different classes.
3. Leased horses must have signed agreements uploaded into oh.4honline.com animal registrations by the 1st Sunday in May.
4. Horses are required to be at the Fair from check-in to release time. Horses going to State Fair are released on Thursday after 10pm. All other horses are released after 10pm on Friday of the County Fair.
5. Horses must have a minimum body score of 4 to show and be present at the Fair. (pg. 11, 4H# 179R).
6. PAS Show Participants for State Fair qualification are required to have their entry form signed by the 4-H Educator. Must qualify in 2 classes with 1 horse. More PAS information on Ohio4h.org.
7. Coggins tests are not required for county. Must have Coggins for PAS & State Fair Shows.
8. Projects not judged at July show receive grades as follows:
 - Dressage - participate in approved dressage tests; judge signature required.
 - Trail - participate in approved competitive trail or endurance ride; proof of participation required.
 - Light Horse Selection - participate in judging clinic or contest; signature of contest coordinator required.
 - Groom & Clean Contest - event held in August, Junior and Senior age teams of 3 may enter.

Project Judging

1. Youth must register for a judging time starting May 1.
2. What to bring for your 4-H project judging? View the project completion requirements at www.go.osu.edu/mcprojectreg
3. 4-H members projects selected for Ohio State Fair participation will be announced on Tuesday at the fair after the opening ceremony in the Entertainment Tent. Packets for Ohio State Fair can be signed out only by the 4-H member or parent after confirmation of attending.
4. Fair premiums will be paid on a maximum of three (3) projects and/or animals. Projects must be judged at the Montgomery County 4-H pre-fair judging or animals on display at the fair in order to receive the fair premium. Premiums consist of \$5.00 per project, up to 3 projects.

4-H Club Booths

1. Booth space must be requested by June 1. Exact locations will be shared with club leaders after June 1.
2. In projects where display is not practical, an educational poster may be displayed. Poster size: minimum 14"x22" and maximum 22"x28".
3. Club booths must be set up by 5:00 p.m. on Saturday, before fair. The building will close and be armed after 5:00 p.m. Exhibits may be removed on Sunday, 7:00 p.m.-9:00 p.m. or on Monday after the fair from 9:00 a.m.-12:00 p.m.
4. Montgomery County Agricultural Society sponsors both rosettes and premiums. Booths will receive a ribbon. Booth cash premiums are a flat of \$40.00.
