

STAGE 1 APPLICATION FORM GUIDANCE FOR APPLICANTS

Funding Programme: Medical Research

Thank you for your interest in The James Tudor Foundation.

We welcome your funding request, and we hope that you will find the application process easy and accessible.

As you prepare to complete your application, please refer to this document. Here we provide the full list of questions you will find on the online form, and guidance on how to complete each section of the form. Of course, some questions are self-explanatory, but we have provided some explanation on others to clarify the information we need from you.

Once you are ready to complete the online application form, you can always save it and resume it at a later stage, if necessary (your unique 'Save & Resume' link generated by the online application form is valid for 30 days).

Please always refer to the <u>submission deadlines for each quarter</u> to make sure that we receive your application on time.

Please note that we only accept <u>online</u> submissions (do not complete and email this document).

In order to access the online application form, you first need to check your eligibility to apply.



Please note that our Board of Trustees doesn't include any medical or scientific experts. To aid our final decision-making, please complete every section of your application **using non-technical language**. You can refer to technical terms such as names of genes or drugs, etc., but you must explain the context, the activities, and the goals of your research using lay terms. We regret that we will not be able to consider medical research applications that do not so.

Please tell us what your project specifically entails and how will it make a difference to patients (500 words max.):	Please explain what your project will specifically focus on and what its intended deliverables are.
	In addition, while your research project will not immediately provide a new clinical application, we would like to understand how it might ultimately do so. There will be further steps that the research will need to take beyond the life of your grant, but please explain what the intended patient benefit would be should your research contribute to future clinical trials.
	For instance, it could be developing a new way of administering a drug to patients (e.g., pills instead of injections) which would make it easier and cheaper for patients to receive their treatment, maybe enabling treatment to be accessible at home rather than in hospital.
	Or it might be a more effective treatment that helps a group of patients who are unresponsive to currently available treatments. Or perhaps a new device or test that enables earlier diagnosis preventing a condition or disease from progressing beyond being responsive to treatment.
