Wedding Contract

BOOKINGS: To secure a date, a signed contract is required with a \$100 non-refundable deposit at the time of signing. Please be advised that a date and the services of Salon on the Hudson's artistic team will only be reserved once a signed contract and deposit are received. The deposit will be deducted from the wedding day balance. All services provided on a Sunday, a holiday or require opening prior to 9am will result in an additional \$200 fee.

ON LOCATION SERVICES: Travel services are offered within 50 miles of Highland Falls, NY. Travel fee: \$200; Non-refundable deposit: \$100 (The deposit will be deducted from the wedding day balance). Please note that the pricing for on-location services differs from in salon services (pricing information can be found on our website: www.salononthehudson.com).

FINAL HEADCOUNT: The final headcount for services rendered will be due in writing (email) 60 days prior to the event. No adjustments may be made after the final headcount for guests that may change their minds or miss their appointment.

CANCELLATION POLICY: In the unfortunate event that Salon on the Hudson's services must be cancelled, your deposit will not be refunded. Cancellations that are received 15-30 days prior to the event will

result in 50% of all planned services charged to the party that has signed the contract. Cancellations that are received 0-14 days prior to the event will result in 100% of all planned services charged to the party that has signed the contract.

PAYMENT INFORMATION: As a part of our wedding agreement, Salon on the Hudson requires a credit card to reserve your wedding date as well as any trial appointments. Your credit card will only be charged if your contract is broken or upon request of the client. Gratuity is not included in the prices provided.
