



Council of Deans of Nursing and Midwifery (Australia and New Zealand) – survey response submission to the Draft National Health and Medical Research Strategy consultation

### 1. Vision

Does the proposed Vision establish the right aspirations for the future of health and medical research in Australia?

The vision could benefit from explicitly stating the ambition for Australia to be a world leader *in translating research into tangible health outcomes* and improving health equity, not just in research output.

The proposed values are appropriate but could be further enhanced by including translation and impact.

A suggestion for improvement is for "Focus area 1, Build a vibrant research system that delivers for the nation". This focus area could be improved by including

reference to the future research workforce, especially early and mid-career researchers.

#### Overall:

- Ensure that research workforce challenges are addressed across all areas.
- Integrate health equity as a cross-cutting theme across all focus areas

<u>Focus area 1:</u> The link to *practical application* could be strengthened. The action should explicitly mention using horizon scanning to inform service delivery models, especially for priority populations.

Focus area 2: Emphasise co-design in all research stages.

<u>Focus area 3:</u> Ensure that funding guidelines acknowledge the time and resources required to build relationships and mobilise research in community settings.

<u>Focus area 4:</u> Change "Continue to Support" to "Prioritise the expansion of randomised controlled trials (RTCs) to focus on Aboriginal and Torres Strait Islander, regional, rural and remote and underserved populations."

<u>Focus area 5:</u> We endorse the "deliver equity – no one left behind" approach and suggest that this is further underlined, particularly for vulnerable groups

### Workforce

The Australian Health and Medical Research Workforce Plan should include strategies that support *community-based researchers* with non-traditional pathways into research, often with precarious employment conditions. We

recognise and support the strategy's proposals around EMCRs, fostering science literacy in schools and additional approaches to sustain researchers and the research pipeline. However, it would be helpful if further emphasis was placed not only on strategies to attract new researchers but also on how they can be supported to have sustainable research careers.

# **Funding**

Basic science research receives significant funding, whereas knowledge translation initiatives receive minimal support. Addressing this disparity requires the development of innovative funding models that enable integrated transdisciplinary research programs. To rebalance the system, there should also be greater prioritisation given to primary care and small health service research programs and recognition of the strategic opportunities they present.

- 3. <u>Consumer and Community Involvement:</u> Meaningful engagement of community and consumers across all stages of health and medical research, from priority setting to translation as far as possible.

<u>Explanation</u>: These priorities align with the Council's emphasis on collaboration, equitable funding, and addressing health inequities. Successful implementation would foster innovation, ensure research translates effectively into practice, and improve accessibility and quality of care for all Australians.

### 8. Metrics

- Impact on Prevention: Monitor the impact of research on reducing the incidence of preventable diseases.
- *Translation Rate*: Measure the time it takes for research findings to be translated into policy and practice.
- Health Equity: Track disparities in health outcomes across different population groups (e.g., socioeconomic status, geographic location, Indigenous status, age).
- Community Engagement: Track the level and quality of community involvement in research projects.

 Workforce Diversity: Monitor the representation of diverse groups (e.g. Aboriginal and Torres Strait Islander researchers, community-based researchers) in the health and medical research workforce.

Over what time periods should these be measured?

These metrics should be measured annually to allow for continuous monitoring and adjustments to the strategy.
