## **RULES**

The Shane L. Goldman Detachment #1278 of the Marine Corps League which is a qualified nonprofit 501 (c) as defined by the Internal Revenue Service is holding a drawing where the drawing will take place on 4/1/2026 and last for 30 days (with option listed below). The drawing will take place each day for each of the 30 days.

- 1. Limit of 500 tickets to be sold: numbering 1 to 500.
- 2. One ticket for each \$100.00 donation. If a winning ticket is chosen it immediately goes back into the raffle for another chance to win.
- 3. Ticket sales will continue until all or sold or March 31, whichever comes first!
- 4. All prizes are new, factory-made firearms.
- 5. By obtaining a raffle ticket you attest that you are a law-abiding citizen of good moral character, may legally possess the firearm(s) won, have intention of using the firearm(s) only in a legal and safe manner, and will or have already obtained instruction on the safe use and operation of the firearm(s) won.
- 6. Daily drawings start on 4/1/2026, as scheduled or later if all tickets are not sold. If the latter, tickets drawings will begin on the 1<sup>st</sup> day of the month after all tickets are sold and continue for 30 days. Tickets will be drawn randomly.
- 7. All firearms won are subject to availability and Wood County Marine Corps League Shane L. Goldman Detachment reserves the right to make substitutions of equal or greater value. A list of firearms in this raffle are listed below and have been purchased by the Detachment.
- 8. Winning ticket numbers and firearm won will be posted on the website <a href="www.woodcountymcl.com">www.woodcountymcl.com</a>. To protect the winner's identity, the winning names will not be posted.
- 9. Proceeds from the "30 Guns in 30 Days Raffle" benefit the Wood County Marine Corps League Shane L. Goldman Detachment #1278 for the charitable purposes of contributing to veterans, benefitting veterans, Detachment missions and projects, veteran activities, their physical wellbeing, funding assisting them in relieving them from hardships such as distress, suffering, or disease as deemed by the Detachment as a whole.
- 10. You must be at least 18 years old and a legal resident of the United States to purchase a ticket.
- 11. Winners must be at least 18 years old to take possession of a rifle or shotgun, and at least 21 years old to take possession of a handgun. Prizes are not transferable. The person designated on

- the ticket must claim the prize. Note: Tickets should not be made out to children below the age of 18 (or 21 as appropriate), as they will not be able to take possession of any firearms.
- 12. Winners will be notified, using the name and Email address and phone number, that the purchaser has written or requested to be on the ticket stub. In the event that Wood County Marine Corps League Shane L. Goldman Detachment #1278 is unable to contact the winner it is the sole responsibility for the winning ticket holder to contact the Wood County Marine Corps League Shane L. Goldman Detachment #1278 to claim their prize. Prizes are not transferable, the person designated on the ticket must claim the prize. ALL PRIZES MUST BE CLAIMED AND TRANSFER COMPLETED WITHIN 30 DAYS OF THE SCHEDULED DATE THE TICKET IS DRAWN.
- 13. Raffle is void where prohibited.
- 14. All Federal Bureau of Alcohol Tobacco and Firearms (BATF) rules apply.
- 15. All firearm transfers will be done through Armed Texans, a Federal Firearms Licensed (FFL) dealer, and all applicable Federal and State laws will apply.
- 16. Transfers will be done by Armed Texans located @ 369 County Road 2784, Mineola, Texas 75773. Armed Texans will not charge a transfer fee unless the firearm must be transferred to another FFL.
- 17. Wood County Marine Corps League Shane L. Goldman Detachment #1278 solely reserves the right to change the location and/or dealer for any transfer. The winning ticket holders must make a transfer through the Wood County Marine Corps League Shane L. Goldman Detachment #1278 selected dealer, and in accordance with all applicable laws.
- 18. Winning ticket numbers are eligible for the remaining drawings. All 500 ticket numbers are in each drawing. (You can win more than once per ticket!) No prizes will be awarded on unsold ticket numbers drawn. There is no cash value of ticket and it can not be exchanged for cash.
- 19. At no time will Wood County Marine Corps League Shane L. Goldman Detachment #1278 take possession of any of the firearms involved in this raffle; winners will receive firearms directly from Armed Texans, LLC, a FFL dealer only, all applicable laws will apply.
- 20. Wood County Marine Corps League Shane L. Goldman Detachment #1278 limits all liability to the purchase price of ticket purchased.
- 21. Cash, personal checks are accepted for the sale of raffle tickets. Raffle prizes will not be awarded until the check clears the bank. Dishonored Checks are subject to additional fee and disqualification from the raffle. There will be a \$25 returned check fee added to the total ticket price.
- 22. All prize winners are responsible for any fees (FFL transfer, taxes, etc.) It is the winner's responsibility to file any reports of winnings as applicable to state and federal law.
