These prices are effective December 28, 2025, and are subject to change without notice.

ITEMIZED SELECTIONS

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Professional Services:

Basic Services of Funeral Director and Staff..... \$1900.00

Our basic services charge includes but is not limited to 24-hour availability of funeral director and/or staff to respond to initial requests for services, arrangement conference with family or responsible party, arrangement of service, tribute or memorialization. Staff to advise, assist and recommend appropriate personalization and individualization of the services to commemorate the unique life of your loved one. Obtaining and recording vital statistics and biographical information. Preparation and transmission of obituary notice, death certificate preparation and filing, and obtaining necessary permits, authorizations, consents and assignments. Coordination with other parties such as hospital, doctor's office and staff, cemetery, crematory, clergy, and others involved in the services and disposition. Sheltering and care of decedent. Also included in this charge are overhead expenses related to our facilities such as professional licensing, administrative services, insurance, maintenance, building and utility expenses, taxes, legal and accounting fees, recording keeping, equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains). This charge is also included in the other packaged funeral offerings as allowed by law.

Preparation:

Embalming..... \$750.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

- A. Cosmetology, Dressing and Placement in Casket *with* Embalming..... \$200.00
- B. Cosmetology, Dressing and Placement in Casket *with no* Embalming..... \$200.00

It is the policy of our firm to require refrigeration of un-embalmed remains within 24 hours per Colorado Mortuary Science Code 12-54-111 (3)

Facilities, Equipment and Staff:

A. Visitation at the Funeral Home or Other Facility \$250.00

Our services include visitation setup, display of floral arrangements, supervision and attendance during the visitation, viewing or wake. Fee is based on two- hour intervals.

- Each additional two hours.....\$250

B. Funeral Service at the Funeral Home or Other Facility..... \$350.00

Our services include coordinating the funeral arrangement, supervision of the funeral, staff coordination of the funeral ceremony, setup and use of facilities and equipment for the funeral ceremony, and cemetery committal service.

C. Memorial Service at Funeral Home or Other Facility..... \$350.00

Our services include coordinating the memorial service, supervision of the ceremony, staff coordination of the ceremony, setup and use of facilities and equipment for the memorial service.

D. Graveside Service..... \$250.00

Our services include coordinating the funeral arrangements at the graveside, supervision of the graveside service, equipment and staff necessary to conduct the graveside service.

E. Private Family Viewing.....\$200.00

This selection is a one (1) hour, **family only** visitation. Our services include visitation setup in the stateroom, display of floral arrangement and staff attendance during the visitation.

F. Additional Charge for Holiday Services.....\$500.00

(Charges apply to Memorial Day, The 4th of July and Labor Day.)

(No services on Christmas Day, Thanksgiving Day, New Year’s Day or Easter Sunday)

Forwarding Remains to another Funeral Home.....\$2,625.00

This charge includes the transfer of the decedent to our funeral home, a proportionate amount of basic services of staff and embalming. This charge does not include the transportation to airport, use of staff and facilities for visitation, rites and ceremonies, minimum shipping container or any other service or merchandise not specifically listed.

Receiving Remains from another Funeral Home..... \$1,475.00

This charge includes temporary shelter of remains, a proportionate amount of basic services of staff, and transfer of remains to funeral home. This charge does not include the use of staff and facilities for visitation, rites and ceremonies, or any other service or merchandise not specifically listed.

Immediate Burial\$2,625.00

This charge includes transfer of deceased to our funeral home, basic services of director and staff, bathing and sanitary care of un-embalmed remains, cosmetology, dressing, and placement in casket of un-embalmed remains, local transportation to the cemetery, and procurement of necessary permits and authorizations.

This charge does not include cemetery or government fees, the use of staff and facilities for visitation, rites and ceremonies, or any other service or merchandise not specifically listed including but not limited to an outer burial container (if required by the cemetery).

Traditional Funeral Service.....\$4,150.00

This includes basic services of director and staff, transfer of remains to the funeral home, embalming, cosmetology dressing and casketing, visitation, funeral service and use of funeral hearse. This package does not include any merchandise, government fees, obituary, flowers or death certificates.

No refund or credit will be issued for package sale goods or services which remain unused by the customer at the time of need.

Graveside Funeral Service.....\$3,750.00

This includes basic services of director and staff, transfer of remains to the funeral home, embalming, cosmetology dressing and casketing, visitation, graveside service and use of funeral hearse. This package does not include any merchandise, government fees, obituary, flowers or death certificates.

Traditional Funeral Followed by Cremation \$4,425.00

This charge includes transfer of deceased to our funeral home, basic services of director and staff, embalming, cosmetology, dressing and casketing, use of facility for visitation and funeral service, cremation fee, procurement of all permits and authorizations. This package does not include any merchandise, government fees, obituary, flowers, death certificates or urns

Cremation with Memorial Service..... \$3,350.00

This charge includes the transfer of the decedent to our funeral home, a proportionate amount of basic services of director and staff, procurement of necessary permits and authorizations, memorial service at funeral home or other facility and cremation fee. This charge does not include merchandise, government fees, obituary, flowers, death certificates or urn.

Celebration of Life with Cremation service with alternative container provided by our funeral home \$3,475.00

Direct Cremation.....\$1,905.00

This charge includes the transfer of the decedent to our funeral home, a proportionate amount of basic services of staff, local transportation to crematory, cremation fee, refrigeration, procurement of necessary permits and authorizations.

This charge does not include government fees, the use of staff and facilities for visitation, rites and ceremonies, or any other service or merchandise not specifically listed.

If you want to arrange a direct cremation you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard and composition materials (with or without an outside covering).
