

ADDENDUM TO THE ADDENDUM TO UMBRELLA MEMORANDUM OF UNDERSTANDING

This Addendum amends the Addendum to the Umbrella Memorandum of Understanding ("Agreement"), and all documents referenced therein between Pasco-Hernando Workforce Board, Inc. dba CareerSource Pasco Hernando ("CareerSource Pasco Hernando"), Pasco Hernando Workforce Development Consortium ("Consortium"), and Pasco County School Board ("PCSB") (collectively "Parties"), dated March ____, 2025. Notwithstanding anything to the contrary in the Agreement, the Parties mutually agree and hereby accept the terms set forth in this Addendum, which shall supersede any conflicting term(s) in the Agreement:

1. Section 1: Individual Partner Contribution of Services, "1.2 Provision of Services," after third bullet point: Add a bullet point to state, "in addition to referring students, PCSB will provide signed parental releases providing CareerSource Pasco Hernando with information to communicate with parents and students in determining eligibility. In exchange for the signed releases, CareerSource Pasco Hernando will provide payment upon availability of funds up to Seventy-Five Thousand and No/100 dollars (\$75,000.00) per year for referrals earned from formula funding.
2. Section III: Partner Contribution, second paragraph, third line: Add, PCSB will provide in-kind contribution of services or pay the agreed upon amount once billed at year end.

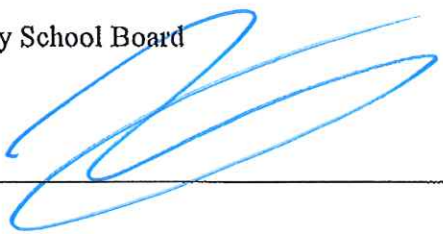
