REGULATIONS

- **I agree to keep my dog on a leash or on a carrier while in public areas (hallways and restaurant garden)**

Those are the only areas where the dog is permitted

- I agree to keep my dog out of the pool and ruf areas.
- I agree **NOT** to use chairs, armchairs, cots or cushions for my pet.
- I agree **NOT** to leave my dog unsupervised in the room and in the common areas allowed for my pet.
- I agree to avoid noise or any other disturbance from my dog, in the interest of other hotel guests.
- I agree to pay any necessary cleaning or repair bills and authorize the hotel to charge my credit card for such charges, including postponing my departure from the hotel, if necessary.
- I agree that, if my dog creates any disturbance that could cause other occupants or hotel staff to file complaints at the hotel, at the request of the Hotel Manager or manager on duty, I will arrange to accommodate my dog elsewhere without any refund.
- I agree **NOT to take my dog out to do his needs** in the hallways and garden area; in case I am surprised I agree to pay the penalty of **\$ 250.00 MXN**; as well as collecting and throwing away what my pet has generated.
- I agree that Cinco Rodavento will only host 2 dogs of 15 kilos or less per Room
- I agree that the stay of my pet in **CINCO RODAVENTO**, will generate an additional charge **per night** that must be charged in advance. **The cost for dogs:**
 - **1 to 30 kilos will be charged \$ 800 pesos per night:**
 - **for more than 30 kilos \$ 1,000.00 pesos per night..**
- I agree to program daily the cleaning service in advance to be done when my pet is not inside the room and in case is necessary to be present while there is any of our staff, meaning Room Service, Housekeeper, Maintenance etc.
- I agree **NOT** to use any of the bed sheets, blankets, pillows on my pet in case of doing so I will pay extra fee at the check-out for the cleaning.



- I agree to assume the responsibility in case my pet generates any disturbance that can cause other guest or staff from the hotel that get affected and complain. The manager on shift will handle the situation and if necessary I will make the arrangements to accommodate my pet in other place with any type of refunds.
- I agree to present **vaccination booklet with vaccines and deworming in force in the last 12 months (yardia, bordetela and rabies); along with the certificate where it is specified that my pet is free of fleas and ticks.**
- I agree to present where it is **certified that my pet belongs to some emotional support program.**

INDEMNITY

In addition, I agree to assume full responsibility for personal injury or property damage caused by the dog suffered by any guest, employee, or guest of the hotel, including the approved veterinarian and his employees if the case of an extraordinary visit arises.

In the event of personal injury or property damage, I agree to indemnify, defend, and hold harmless **CINCO RODAVENTO** and the approved veterinarian together with their officers, directors, employees, agents, lawyers, insurers, past or present. Affiliated companies, successors, and assigns, for any claims that may arise.

GENERAL RELEASE

In consideration of **CINCO RODAVENTO**, allowing me to stay my dog in the hotel during my stay. I, and my successors and assigns, release and terminate **CINCO RODAVENTO**, together with its officers, directors, employees, agents, attorneys, insurers, affiliated companies, successors and assigns past or present, from all past or present actions, judgments, debts, invoices, contracts, controversies, agreements, promises, transgressions, damages, judgments, claims and demands of any kind, at law or in equity, known or unknown, that I or my successors or assigns have had, now have or hereafter, and including, but not limited to, any claim relating in any way to my stay at the Hotel relating to the presence of my dog on or on the Premises of the Hotel against or in connection with **CINCO RODAVENTO**.
