We are able to partner with more than 70 community agencies and the thousands of families they help us reach. Each month, we provide tens of thousands of items to food pantries, community centers, clinics, home visiting programs, and hospitals.

THE STATE OF DIAPER NEED

Before the onset of COVID-19, one in three families in the U.S.

struggled to afford to buy enough diapers for their young children. But while diaper need has long been a condition

> of living in poverty, it has become even more pervasive over the course of the pandemic and its

continued aftermath.

Commodity prices continue to rise as manufacturers grapple with supply chain challenges and worker shortages. Diaper prices jumped nearly 12 percent in the 18 months ending in June of 2021 according to data from consulting firm AlixPartners, with several diaper makers increasing prices since then. Even a modest increase in the price of goods can make household items like diapers unaffordable for low-income families.

According to Bloomberg News, packages of diapers that cost about \$25 in 2020 cost up to \$40 in 2021 and that baby-care items from rash salves to wipes saw double-

digit increases that continue to rise.

In response to these challenges, the demand on diaper banks increased by about 70 percent in 2021, according to the National Diaper Bank Network.

ShareBaby is dedicated to alleviating diaper insecurity in the lives of vulnerable young children.


