129/Cox Road/Liberty Way

Greg Wilkens commented that this project is moving along, but it could be a struggle to finish on time.

Millikin – I-75 Interchange

Director Corey commented that the BCTID submitted an OKI STBG application for Cincinnati-Dayton Road and Millikin Road Roundabout. OKI had received 22 applications for the 4 counties in Ohio. OKI will announce the recipients of funds in the September/October timeframe.

North Hamilton Crossing Project (See Director's Report)

Director Corey commented that this project has been delayed in moving to the next milestone, with respect to the ODOT Plan Development Process, due to the recent announcement of a substantial development in the project area. There are one to two dozen alignments that are currently being evaluated within the traffic model. The new development in this area, in addition to the environmental issues, will have a major bearing on the alignment that will ultimately be chosen. Currently there is no shareholder meeting scheduled.

SR129 – Stairs

Director Corey spoke briefly on the stairs along SR129 (between Garfield Middle School and the Butler County Board of Elections) that are in need of maintenance.
