3. Rules & Regs for all Visitors

All visitors must abide by Seascope HOA's Rules & Regs. Violations of Seascope HOA rules may result in a \$100 fine.

- Unit occupancy may not exceed the standards set by Seascope HOA Rules & Regs Oct. 2019. Violators will be reported to County Code Enforcement Office or Fire Marshal, which may result in fines and/or removal of occupants.
- **All vehicles must clearly display an accurately completed vehicle pass while on Seascope property. All fields on the vehicle passes must be accurately completed and legible, preferably with a black marker. Failure to accurately complete these fields will result in a \$25.00 ticket, without warning.**
- Photocopied, laminated, incomplete, or modified vehicle passes, or any violation of HOA rules will be subject to a \$100 fine.
- Observe posted speed limits. Park in paved areas only. Do not park on grass, sand or tow-away zones.
- Unauthorized vehicles, those parking illegally or without a valid vehicle pass, may be towed at the owner's expense by an authorized towing company.
- Campers, RVs, boats, trailers, and oversized vehicles are not allowed to park on the streets or in Seascope HOA parking areas. They must be kept in off-site storage facilities.
- Keep noise to a minimum after 10:00 pm and before 8:00 am.
- Report suspicious activity or emergency conditions to management at 850-269-0122.
- The acceptance of this vehicle pass relieves the issuer or its agents of any responsibility for damages or loss to vehicles, their contents or accessories.
