



STUDENT DECLARATION & ACKNOWLEDGEMENT

1. I declare that all information provided in my Enrolment Form is true and correct to the best of my knowledge. I understand that providing false or misleading information may affect my enrolment and is an offence.
2. I understand that I am required to complete a Language, Literacy and Numeracy (LLN) assessment to determine my suitability for the course.
 - I understand that all training, assessments and communication at Blue Horse Truck Driver Training is conducted in English. I confirm that I have sufficient English language skills to understand instructions, participate in training and demonstrate competency in assessments, including safety-critical activities.
3. I understand that all Blue Horse Truck Driver Training (BHTDT) courses include a combination of:
 - Reading and written knowledge assessments
 - Verbal questioning
 - One-on-one tuition
 - Practical, hands-on driver training
 - A final Practical Driving Assessment (PDA) requiring demonstration of competency
4. I acknowledge that both the theory and practical components of the course must be completed prior to undertaking the PDA. I understand that incomplete theory may reduce my available on-road training time.
5. I understand that a Statement of Attainment (SoA) will only be issued once I have been assessed as competent in all required assessments.
6. I am solely responsible for ensuring that my Western Australian driver's licence is valid, current and appropriate for training (not a provisional licence) at the time of training. I understand that no refund or credit will be provided if I am unable to proceed due to licence issues.
7. While participating in training, I accept responsibility for:
 - Payment of any insurance excess in the event of an at-fault accident
 - Any fines resulting from traffic infringements committed by me
 - Any damage to vehicles or property caused during training
8. I understand that training includes mandatory rest breaks as part of the course duration. Any additional breaks requested may reduce my total on-road training time.
9. I acknowledge that an eyesight test, in accordance with Department of Transport (DoT) requirements, will be conducted prior to training. If I do not meet the required standard, training will not proceed and a refund will be issued less a \$100 administration fee.
10. If I require prescription eyewear to drive, I will wear it during the eyesight test and throughout all training activities and will inform the trainer/assessor.

11. I will disclose at the time of booking any medical condition(s) that may impact my ability to safely participate in training. I understand that training will not proceed without appropriate medical clearance where required by DoT.
12. I confirm that I have disclosed any learning conditions, disabilities or restrictions that may impact my participation in training or assessment.
13. I understand that additional fees are payable directly to the Department of Transport when lodging applications for licence upgrade.
14. I acknowledge that postponed or deferred PDAs are held in credit for a maximum period of three (3) months from the last training date. I understand that no refund is available if I do not proceed within this timeframe.
15. I understand that if I am assessed as not yet competent in the PDA, a re-assessment fee will apply.
16. I confirm that I have read and understood the Refund and Cancellation Policy, including that:
 - Cancellations made five (5) or more working days in advance may be eligible for a refund less a \$100 administration fee
 - Cancellations within five (5) working days of the course commencement date will forfeit all fees paid
 - Non-attendance or same-day cancellation will be treated as a no-show and all fees will be forfeited
17. I understand that training cannot be rescheduled under the existing booking if I cancel or do not attend. A new booking and full payment will be required.
18. I acknowledge that if I attend training and am suspected of being under the influence of drugs or alcohol, training may be cancelled immediately with no refund.
19. For Assessment-Only enrolments, I understand that no practical training will be provided and that I must present valid evidence (e.g. Statement of Attainment or completed theory assessment) prior to undertaking the PDA.
20. I consent to being contacted by BHTDT for direct marketing purposes, including course updates and promotional information.
21. I grant permission for BHTDT to use photographs, video footage and/or written testimonials obtained during training for marketing and promotional purposes, including social media.
22. I understand that where a third party (e.g. employer or organisation) is responsible for payment of my course fees, they remain responsible for full payment, including in the event of cancellation or non-attendance, in accordance with the Cancellation Policy.
