OVER 76% OF CARE PROVIDERS HAVE DSPT IN PLACE

An article from The Digital Care Hub has announced that a fantastic 21,780 care providers have completed their DSPT!! That is a real achievement.....

We're delighted to announce that, as of 30 June deadline, just over 76% of care providers across England have the Data Security and Protection Toolkit (DSPT) in place – a brilliant milestone that shows real commitment to data protection across the adult social care sector. In total, 21,780 providers are now DSPT-compliant, including 12,598 care homes and 9,182 non-care home services such as homecare, supported living, and extra care housing.



We want to say a huge congratulations to all care providers who completed the toolkit, and a sincere thank you to our Local Support Organisations, whose support and encouragement helped thousands of services reach this milestone.

Care sector making great progress on data protection

This year's figures show strong progress across the sector:

- 86% of care homes in England are now DSPT-compliant.
- 65% of non-care home services including home care and supported living are also DSPT-compliant.

These numbers reflect the growing awareness and commitment across the sector to keep people's confidential information safe and to build trust in how data is used and shared. Providers who complete the DSPT are not only meeting legal and contractual requirements but are also improving their cyber resilience and readiness for greater integration with NHS systems.

The DSPT opens up opportunities for your service to:

- Share information digitally across health and care networks
- Be part of projects that allow care services to directly access NHS patient information systems, for example, GP records and shared care records
- Save you and your staff time and therefore improve the quality of care for the people you support.

Central and local government bodies, local authority, ICB's (Integrated Care Boards), the Care Quality Commission and the National Data Guardian recognise The Toolkit as the official tool to evaluate care providers' compliance with legal requirements, Data Security Standards and good practice.

DATA (USE AND ACCESS) ACT 2025: BRIEFING FOR ADULT SOCIAL CARE PROVIDERS

The Data (Use and Access) Act 2025 became law on 19 June 2025, following Royal Assent. This legislation introduces wide-ranging reforms to improve how data is accessed, shared, and protected across public and private services in the UK. It has particular relevance to the adult social care sector due to its emphasis on information standards, data protection, and improved data sharing between organisations.

While not all parts of the Act apply directly to adult social care, the Act includes several important provisions that will affect how providers manage digital care records, interact with NHS systems, and meet legal duties relating to data protection and cyber security.

Data (Use and Access) Act 2025: what care providers need to consider

The Data (Use and Access) Act 2025 became law in June, introducing wide-ranging reforms to how personal data is used and protected across the UK. The Act affects all organisations that process personal data—including adult social care providers.

To help care services understand what's changing, **Digital Care Hub** has published a dedicated briefing explaining how the Act applies to adult social care and what providers can do to prepare.

We are in the process of designing a training session to help providers understand the law better. We expect it to be available sometime in September.

IMPORTANT INFORMATION FOR CARE WORKERS

SUPPORTING TELECARE USERS DURING THE DIGITAL PHONE SWITCHOVER

What is happening?

· Landlines in the UK are changing. This is called the digital phone switchover.

Why does this matter?

- Some people use telecare devices, like personal alarm pendants that alert call centres or carers in an emergency. These devices work through the phone line and might stop working properly after the phone line changes, unless the person you care for (or someone on their behalf) takes action.
- People who use telecare should call their landline provider as soon as possible to tell their provider that they use telecare.

What does telecare look like?

You might see the person you care for wearing a pendant alarm:

- · Given the importance of these alarms in an emergency, we want to make sure people with telecare alarms (and their friends and family) know what to do to keep these important alarms working properly.
- On 2nd June 2025, a national awareness campaign will launch (broadcasted through various channels, including TV, newspapers, radio and social media) to raise awareness of the digital switchover and so you might be asked questions about the switchover by the people you care for., or technical support which could leave your devices and data at risk. This quick guide explains what you it means and what you need to do.

What do I need to do?

If someone you care for has a telecare device, here's how you can help:

- Encourage telecare users and/or their friends/families to act.
- People who use telecare alarms must call their landline provider. They should tell their landline provider that they use telecare. This is essential as the landline provider will then help make sure their alarm keeps working through the switchover. If they do not know who their landline provider is, this information will be available on their landline bill.
- · If the person you care for is not able to take these steps themselves, they may need help from friends, family, carers or other staff.


FAQ'S

How will contacting the landline provider help?

The landline provider will update their records so that they know that this person has a telecare device. This means they will take extra steps to help make sure the telecare device continues to work during the switchover.

Are all kinds of telecare alarms impacted by the switchover?

There are lots of different types of telecare alarms. Analogue telecare devices rely on the old analogue lines but regardless of the type of alarm, the telecare user should call the landline provider, even if they think their device is already digital.







I work in a community/sheltered housing setting with telecare devices, what do I need to

Some telecare alarms are built into the building while others are individual plug-in devices which may run

through the individual's landline. Either way, the advice is the same. The landline provider should be contacted. If the telecare device is built into the building, telecare users (or someone on their behalf) may

also want to talk to the person or service who runs their building.

I'm not very good with technology and I don't know about telecare, is that a problem?

No, you do not need to fix anything or check equipment. The most important thing is to encourage those you care for (or their friends/family) to call the landline provider if you think they use a telecare alarm.

BE AWARE OF SCAMS

Some criminals have used the switchover as an opportunity to scam, for example tricking people into providing their personal information, passwords or bank details. If you think someone has been a victim of a scam or fraud relating to telecare, report this as a safeguarding concern and advise them to contact their bank and also Action Fraud by calling 0300 123 2040.



We'll also touch on how data breaches can affect your "Safe" rating, and where business continuity planning fits in — though that's explored more fully in a separate session.


