Admissions Policy

Young unaccompanied, under 16-year-olds MAY at the discretion of the organisers be refused admission.

Searching is a condition of entry to the event, to protect your safety and that of our other visitors and our staff. We may conduct searches of clothing, bags and other items determined by us using our reasonable discretion.

No one will be admitted to the event who appears to be under the influence of alcohol and or drugs.

Admission may be refused, or you may be asked to leave the event if you are found to be in possession of any illegal or contraband goods. You may also be liable to prosecution.
