Mayor Ratliffe called the meeting to order. City Clerk/Treasurer Hembrey called the roll. Council members present were Michael Allen, Allen Edwards, Carol Falwell, Wendell Green, Regina Lake, and Andy May. City Attorney Pettie was present. Council Members Mansko and Moss were absent.

Following the invocation by Carol Falwell, those present recited the Pledge of Allegiance.

A motion by Lake and second by Falwell to approve the minutes of the December 1, 2025 Meeting carried (6/0) with “yes” votes by Allen, Edwards, Falwell, Green, Lake and May.
