**Child Care hours for the school year are from 6:30 – 7:15 am and 2:30 - 5:30 pm**

**Registration Fee:** A non-refundable \$30.00 per family Registration Fee may be paid in a one-time payment of \$30.00, or as \$10.00 payments each time the childcare is used for a maximum of 3 payments. The registration fee is considered fulfilled when a total of \$30.00 has been paid.

**Late Pick-Up Fee:** A Late Pick-Up Fee will be assessed at a rate of \$1.00 per minutes after 5:30 pm Payment of this fee is due within one week.

**Late Planner Fee:** A \$7.00 Late Planner Fee will be assessed for not submitted by:

- Weekly or Monthly payment -no later than Thursday of each week by 5:30 pm of the week before the planner is in effect.

**Hourly Rate:** A flat hourly rate of \$6.00 per hour per child is charged to utilize the childcare program. Payment is due when submitting the Weekly or Monthly Planner.
